AMENDMENTS TO HOUSE BILL 557

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Stewart” and substitute “Stewart, Anderton, Barve, Ciliberti, Harrison, Healey, Holmes, Jacobs, Love, Otto, Ruth, Terrasa, Wells, and Wivell”; in lines 2 and 17, in each instance, after “Motor” insert “Scooter”; in line 2, after “Electric” insert “Low Speed”; in line 3, after “scooter” insert “and electric low speed scooter”; in line 5, strike “phone number” and substitute “display with contact information”; in line 6, strike “or” and substitute “scooter and”; in the same line, after “electric” insert “low speed”; in line 8, after “standards;” insert “providing for a delayed effective date;”; in line 9, after “motor” insert “scooter”; in the same line, after “electric” insert “low speed”; in line 12, after “Section” insert “11-117.2 and”; and in line 18, after “Electric” insert “Low Speed”.

AMENDMENT NO. 2

On page 1, after line 23, insert:

“11-117.2.

(a) “Electric low speed scooter” means a vehicle that:

(1) Is designed to transport only the operator;

(2) Weighs less than 100 pounds;

(3) Has single wheels in tandem or a combination of one or two wheels at the front and rear of the vehicle;

(4) Is equipped with handlebars and a platform designed to be stood on while riding;

(5) Is solely powered by an electric motor and human power; and

(6) Is capable of operating at a speed of up to 20 miles per hour.

(b) “Electric low speed scooter” does not include:

(1) An electric personal assistive mobility device; or

(2) An electric wheelchair or other mobility aid used by a disabled individual.”.

On page 2, in line 15, after “**MOTOR**” insert “**SCOOTER**”; in the same line, after “**ELECTRIC**” insert “**LOW SPEED**”; in line 19, after “**MOTOR**” insert “**SCOOTER**”; in lines 19 and 27, in each instance, strike “**OR**” and substitute “**AND**”; in the same lines, in each instance, after “**ELECTRIC**” insert “**LOW SPEED**”; and in line 28, after “**MOTOR**” insert “**SCOOTER**”.

On page 3, in line 1, strike “**PHONE NUMBER**” and substitute “**DISPLAY WITH CONTACT INFORMATION**”; in lines 14 and 15, strike “July 1, 2020” and substitute “**January 1, 2021**”; in line 4, strike “**OR**” and substitute “**SCOOTER AND**”; and in the same line, after “**ELECTRIC**” insert “**LOW SPEED**”.
