CHAPTER _____

1 AN ACT concerning

2 **Maryland Department of Health – Biosafety Level 3 Laboratories in Frederick**
3 **County**

4 FOR the purpose of requiring the Maryland Department of Health to develop and make
5 available a certain form; requiring certain biosafety level 3 (BSL–3) laboratories in
6 Frederick County to report certain information to the Department on or before a
7 certain date each year; requiring the Department to report, on or before a certain
8 date each year, the number and location of the laboratories, ~~in total and by local~~
9 ~~jurisdiction,~~ to the Maryland Emergency Management Agency and certain officials
10 in ~~each local jurisdiction in the State~~ Frederick County and the total number of the
11 laboratories to the Governor and the General Assembly; providing that, except as
12 provided under certain provisions of this Act, certain information is confidential and
13 not subject to inspection under certain provisions of law; requiring that certain
14 information be made available if requested by certain entities and in certain
15 proceedings; requiring that certain activities be considered ultrahazardous and
16 abnormally dangerous; providing that certain BSL–3 laboratories are strictly liable
17 for certain damages under certain circumstances; requiring the Department to
18 develop a strategy for a certain purpose; defining a certain term; providing for the
19 application of certain provisions of this Act; and generally relating to biosafety level
20 3 (BSL–3) laboratories in Frederick County.

21 BY adding to

22 Article – Health – General

23 Section 17–701 to be under the new subtitle “Subtitle 7. Biosafety Level 3 (BSL–3)

24 Laboratories in Frederick County”

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article – Health – General**

6 **SUBTITLE 7. BIOSAFETY LEVEL 3 (BSL–3) LABORATORIES IN FREDERICK**
7 **COUNTY.**

8 **17–701.**

9 (A) IN THIS SECTION, “BSL–3 LABORATORY” MEANS A LABORATORY
10 DESIGNATED AS A BIOSAFETY LEVEL 3 (BSL–3) LABORATORY BY THE U.S.
11 DEPARTMENT OF HEALTH AND HUMAN SERVICES, CENTERS FOR DISEASE
12 CONTROL AND PREVENTION, NATIONAL INSTITUTES OF HEALTH, BIOSAFETY IN
13 MICROBIOLOGICAL AND BIOMEDICAL LABORATORIES, AS APPLICABLE, BASED ON:

14 (1) USAGE OF BIOLOGICAL AGENTS THAT MAY CAUSE SERIOUS OR
15 POTENTIALLY LETHAL DISEASE AFTER INHALATION, INGESTION, OR ABSORPTION;
16 AND

17 (2) REQUIRED BIOCONTAINMENT PRECAUTIONS.

18 (B) THIS SECTION APPLIES TO EACH BSL–3 LABORATORY IN ~~THE STATE~~
19 FREDERICK COUNTY THAT:

20 (1) DOES NOT WORK WITH FEDERALLY REGULATED BIOLOGICAL
21 SELECT AGENTS AND TOXINS OR THEIR PRODUCTS; AND

22 (2) (I) IS A COMMERCIAL OR FOR–PROFIT LABORATORY;

23 (II) IS OWNED BY OR IS PART OF A TEACHING HOSPITAL OR AN
24 INSTITUTION OF POSTSECONDARY EDUCATION; OR

25 (III) IS A PRIVATELY FUNDED BIOMEDICAL RESEARCH
26 LABORATORY.

27 (C) THE DEPARTMENT SHALL DEVELOP AND MAKE AVAILABLE A
28 STANDARDIZED FORM FOR A BSL–3 LABORATORY SUBJECT TO THIS SECTION TO
29 USE TO PROVIDE THE INFORMATION REQUIRED UNDER SUBSECTION (D) OF THIS
30 SECTION.

1 (D) ON OR BEFORE OCTOBER 30 EACH YEAR, EACH BSL-3 LABORATORY
2 SUBJECT TO THIS SECTION SHALL REPORT TO THE DEPARTMENT:

3 (1) THE ADDRESS OF THE LABORATORY;

4 (2) THE NAME, TELEPHONE NUMBER, AND E-MAIL ADDRESS OF A
5 CONTACT PERSON FOR THE LABORATORY; AND

6 (3) ANY OTHER INFORMATION REQUIRED BY THE DEPARTMENT TO
7 DETERMINE THE LOCATION OF THE LABORATORY.

8 (E) ON OR BEFORE DECEMBER 31 EACH YEAR, THE DEPARTMENT SHALL
9 REPORT TO:

10 (1) THE MARYLAND EMERGENCY MANAGEMENT AGENCY AND THE
11 HEALTH OFFICER AND EMERGENCY MANAGEMENT OFFICIALS OF ~~EACH LOCAL~~
12 ~~JURISDICTION IN THE STATE~~ FREDERICK COUNTY THE NUMBER AND LOCATION, ~~IN~~
13 ~~TOTAL AND BY LOCAL JURISDICTION,~~ OF BSL-3 LABORATORIES SUBJECT TO THIS
14 SECTION; AND

15 (2) THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1257 OF THE
16 STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY THE TOTAL NUMBER OF
17 BSL-3 LABORATORIES SUBJECT TO THIS SECTION.

18 (F) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION
19 AND SUBSECTION (E) OF THIS SECTION, ANY INFORMATION THE DEPARTMENT
20 COLLECTS FROM BSL-3 LABORATORIES SUBJECT TO THIS SECTION IS
21 CONFIDENTIAL AND NOT SUBJECT TO INSPECTION UNDER THE PUBLIC
22 INFORMATION ACT.

23 (2) ANY INFORMATION THE DEPARTMENT COLLECTS FROM BSL-3
24 LABORATORIES SUBJECT TO THIS SECTION SHALL BE MADE AVAILABLE IF
25 REQUESTED BY THE BSL-3 LABORATORY'S INSURANCE CARRIER OR IN A LEGAL
26 PROCEEDING.

27 (G) (1) ACTIVITY OF A BSL-3 LABORATORY SUBJECT TO THIS SECTION
28 THAT FAILS TO REPORT THE INFORMATION REQUIRED UNDER SUBSECTION (D) OF
29 THIS SECTION SHALL BE CONSIDERED ULTRAHAZARDOUS AND ABNORMALLY
30 DANGEROUS.

31 (2) A BSL-3 LABORATORY SUBJECT TO THIS SECTION THAT FAILS TO
32 REPORT THE INFORMATION REQUIRED UNDER SUBSECTION (D) OF THIS SECTION IS
33 STRICTLY LIABLE FOR DAMAGES FOR ANY INJURY, DEATH, OR LOSS TO PERSON OR
34 PROPERTY THAT IS CAUSED BY THE BSL-3 LABORATORY.

1 SECTION 2. AND BE IT FURTHER ENACTED, That:

2 (a) The Maryland Department of Health shall develop a strategy to attempt to
3 identify biosafety level 3 laboratories that are subject to Section 1 of this Act for the purpose
4 of notifying the laboratories of the requirements of this Act.

5 (b) The strategy may rely on the list of possible laboratories used by the 2013
6 Workgroup on Biocontainment Laboratory Oversight convened by the Maryland
7 Department of Health, information available from biotechnology councils and scientific
8 groups, information available from local government agencies, and other sources that may
9 help to identify biosafety level 3 laboratories subject to Section 1 of this Act.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2020.
