A BILL ENTITLED

1 AN ACT concerning

2 **Family Law – Removal of Child From Home – Meetings**

3 FOR the purpose of specifying that, at any meeting of a local department of social services
4 during which the removal of a child from the child’s home is discussed, certain
5 information is required to be redacted and is prohibited from being referenced;
6 requiring the local department to keep minutes of certain meetings; providing for the
7 application of this Act; and generally relating to local departments of social services.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Family Law**

16 **5–525.3.**

17 **(A) AT ANY MEETING OF A LOCAL DEPARTMENT DURING WHICH THE**
18 **REMOVAL OF A CHILD FROM THE CHILD’S HOME IS DISCUSSED, THE FOLLOWING**
19 **INFORMATION SHALL BE REDACTED FROM THE CASE FILE AND MAY NOT BE**
20 **REFERENCED:**

21 **(1) THE NAME OF THE CHILD AND THE CHILD’S PARENTS;**

22 **(2) THE GENDER OF THE CHILD AND THE CHILD’S PARENTS;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(3) THE RACE OR ETHNICITY OF THE CHILD AND THE CHILD'S**
2 **PARENTS;**

3 **(4) THE SEXUAL ORIENTATION OF THE CHILD AND THE CHILD'S**
4 **PARENTS;**

5 **(5) THE ADDRESS OF THE CHILD AND THE CHILD'S PARENTS;**

6 **(6) THE BIRTH ORDER OF THE CHILD AND THE NUMBER OF CHILDREN**
7 **OF THE PARENTS;**

8 **(7) THE RELIGIOUS AFFILIATION OR BELIEFS OF THE CHILD AND THE**
9 **CHILD'S PARENTS;**

10 **(8) THE POLITICAL AFFILIATION OR BELIEFS OF THE CHILD AND THE**
11 **CHILD'S PARENTS;**

12 **(9) THE MARITAL STATUS OF THE CHILD'S PARENTS;**

13 **(10) THE INCOME OF THE CHILD'S PARENTS;**

14 **(11) THE EDUCATION LEVEL OF THE CHILD'S PARENTS;**

15 **(12) IF THE CHILD IS RECEIVING INSTRUCTION IN ACCORDANCE WITH**
16 **§ 7-301 OF THE EDUCATION ARTICLE, THE TYPE OF EDUCATION CHOSEN BY THE**
17 **PARENTS FOR THE CHILD; AND**

18 **(13) ANY PRIOR INVESTIGATION OF THE CHILD'S PARENTS FOR CHILD**
19 **ABUSE OR NEGLECT THAT RESULTED IN AN UNSUBSTANTIATED OR RULED OUT**
20 **FINDING.**

21 **(B) A LOCAL DEPARTMENT SHALL KEEP MINUTES OF ANY MEETING DURING**
22 **WHICH THE REMOVAL OF A CHILD FROM THE CHILD'S HOME IS DISCUSSED.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2020.
