A BILL ENTITLED

1 AN ACT concerning

2 **Gaming – Sports Betting – Implementation**

3 FOR the purpose of authorizing certain license holders to accept wagers on certain sporting
4 events from certain individuals and by certain methods; requiring the State Lottery
5 and Gaming Control Commission to regulate sports wagering in the State; requiring
6 the State Lottery and Gaming Control Agency to provide certain assistance to the
7 Commission; requiring certain persons to apply to the Commission for certain
8 licenses; requiring certain applicants to sign certain memoranda of understanding
9 relating to compliance with the Minority Business Enterprise Program as a condition
10 of the Commission's approval of certain licenses; authorizing the Commission to
11 provide waivers or exemptions from certain licensing requirements under certain
12 circumstances; requiring applicants for certain licenses to pay certain fees set by the
13 Commission; requiring an applicant for a certain sports wagering license or the
14 renewal of the license to pay a certain fee for the license or renewal; establishing
15 certain license terms for a certain number of years; providing for the distribution of
16 certain licensing fees collected by the Commission; requiring the Commission to
17 deny, suspend, or revoke a license and reprimand or fine a licensee under certain
18 circumstances; authorizing the Commission to impose a certain penalty under
19 certain circumstances; establishing certain procedures and requirements for the
20 issuing of certain licenses; authorizing certain sports wagering licensees to enter into
21 certain agreements for the operation of online sports wagering; providing that an
22 individual may register for online sports wagering either in person or online;
23 prohibiting certain individuals from making a wager and certain sports wagering
24 licensees from accepting a wager from certain individuals; requiring certain sports
25 wagering licensees to establish certain procedures, provide certain safeguards, and
26 report certain information to the Commission relating to sports wagering; providing
27 for the accounting and distribution of certain sports wagering proceeds and certain
28 unclaimed winning wagers; requiring the Commission to adopt certain regulations;
29 requiring the Commission to report annually to the Governor and the General
30 Assembly on certain matters on or before a certain date; declaring the intent of the
31 General Assembly; making conforming changes; defining certain terms; submitting

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

23 (a) In this subtitle the following words have the meanings indicated.

24 (k) “Commission” means the State Lottery and Gaming Control Commission.

25 9–1A–03.

26 (a) Except as provided in subsection (b) of this section, any additional forms or
27 expansion of commercial gaming other than as expressly provided in this subtitle **AND**
28 **SUBTITLE 1E OF THIS TITLE** are prohibited.

29 (b) This subtitle, including the authority provided to the Commission under this
30 subtitle, does not apply to:

31 (1) lotteries conducted under Subtitle 1 of this title;

32 (2) wagering on horse racing conducted under Title 11 of the Business
33 Regulation Article;

1 (3) the operation of slot machines as provided under Titles 12 and 13 of the
2 Criminal Law Article; or

3 (4) other gaming conducted under Titles 12 and 13 of the Criminal Law
4 Article.

6 (a) There is an Education Trust Fund which is a special, nonlapsing fund that is
7 not subject to § 7-302 of the State Finance and Procurement Article.

8 (b) (1) There shall be credited to the Education Trust Fund all proceeds
9 allocated to the Fund under § 9-1A-27 of this subtitle **AND SUBTITLE 1E OF THIS TITLE.**

10 **SUBTITLE 1E. SPORTS WAGERING.**

11 **9-1E-01.**

12 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
13 INDICATED.

14 (B) "COMMISSION" HAS THE MEANING STATED IN § 9-1A-01 OF THIS TITLE.

15 (C) "ONLINE SPORTS WAGERING" MEANS SPORTS WAGERING THROUGH AN
16 ONLINE GAMING SYSTEM:

17 (1) ON A COMPUTER, A MOBILE DEVICE, OR ANY OTHER INTERACTIVE
18 DEVICE; AND

19 (2) THAT IS ACCEPTED BY A SPORTS WAGERING LICENSEE OR AN
20 ONLINE SPORTS WAGERING OPERATOR.

21 (D) "ONLINE SPORTS WAGERING OPERATOR" MEANS AN ENTITY THAT
22 HOLDS A LICENSE ISSUED BY THE COMMISSION UNDER THIS SUBTITLE TO OPERATE
23 ONLINE SPORTS WAGERING ON BEHALF OF A SPORTS WAGERING LICENSEE.

24 (E) "PROCEEDS" MEANS THE PART OF THE AMOUNT OF MONEY WAGERED
25 ON SPORTING EVENTS UNDER THIS SUBTITLE THAT IS NOT RETURNED TO
26 SUCCESSFUL BETTORS BUT IS OTHERWISE ALLOCATED UNDER THIS SUBTITLE.

27 (F) (1) "SPORTING EVENT" MEANS:

28 (I) A PROFESSIONAL SPORTS OR ATHLETIC EVENT;

1 (II) A COLLEGIATE SPORTS OR ATHLETIC EVENT;

2 (III) AN OLYMPIC OR INTERNATIONAL SPORTS OR ATHLETIC
3 EVENT IN WHICH THE MAJORITY OF THE PARTICIPANTS ARE AT LEAST 18 YEARS
4 OLD;

5 (IV) AN ELECTRONIC SPORTS OR VIDEO GAME COMPETITION:

6 1. SANCTIONED BY AN ESPORTS GOVERNING ENTITY;
7 AND

8 2. IN WHICH EACH PARTICIPANT IS AT LEAST 18 YEARS
9 OLD;

10 (V) A MOTOR RACE EVENT SANCTIONED BY A MOTOR RACING
11 GOVERNING ENTITY; OR

12 (VI) ANY PORTION OF A SPORTING EVENT, INCLUDING THE
13 INDIVIDUAL PERFORMANCE STATISTICS OF ATHLETES OR COMPETITORS IN A
14 SPORTING EVENT.

15 (2) "SPORTING EVENT" DOES NOT INCLUDE:

16 (I) A HIGH SCHOOL SPORTS OR ATHLETIC EVENT; OR

17 (II) A FANTASY COMPETITION REGULATED UNDER SUBTITLE
18 1D OF THIS TITLE.

19 (G) "SPORTS WAGERING" MEANS THE BUSINESS OF ACCEPTING WAGERS ON
20 ANY SPORTING EVENT BY ANY SYSTEM OR METHOD OF WAGERING, INCLUDING
21 SINGLE-GAME BETS, TEASER BETS, PARLAYS, OVER-UNDER, MONEYLINE, POOLS,
22 EXCHANGE WAGERING, IN-GAME WAGERING, IN-PLAY BETS, PROPOSITION BETS,
23 AND STRAIGHT BETS.

24 (H) "SPORTS WAGERING LICENSE" MEANS A LICENSE ISSUED BY THE
25 COMMISSION UNDER THIS SUBTITLE THAT AUTHORIZES THE HOLDER TO ACCEPT
26 WAGERS ON SPORTING EVENTS.

27 (I) "SPORTS WAGERING LICENSEE" MEANS THE HOLDER OF A SPORTS
28 WAGERING LICENSE.

29 (J) "SPORTS WAGERING LOUNGE" MEANS A NONSMOKING AREA LOCATED
30 IN A VIDEO LOTTERY FACILITY WHERE SPORTS WAGERING IS CONDUCTED.

1 **(K) (1) “VIDEO LOTTERY FACILITY” HAS THE MEANING STATED IN §**
2 **9-1A-01 OF THIS TITLE.**

3 **(2) “VIDEO LOTTERY FACILITY” DOES NOT INCLUDE A LOCATION IN**
4 **THE FACILITY WHERE SATELLITE SIMULCAST BETTING IS CONDUCTED.**

5 **(L) “VIDEO LOTTERY OPERATION LICENSE” HAS THE MEANING STATED IN §**
6 **9-1A-01 OF THIS TITLE.**

7 **(M) “VIDEO LOTTERY OPERATOR” HAS THE MEANING STATED IN § 9-1A-01**
8 **OF THIS TITLE.**

9 **9-1E-02.**

10 **(A) (1) THE COMMISSION SHALL REGULATE THE OPERATION OF SPORTS**
11 **WAGERING IN ACCORDANCE WITH THIS SUBTITLE.**

12 **(2) THE STATE LOTTERY AND GAMING CONTROL AGENCY SHALL**
13 **PROVIDE ASSISTANCE TO THE COMMISSION IN THE PERFORMANCE OF THE**
14 **COMMISSION’S DUTIES UNDER THIS SUBTITLE.**

15 **(B) THIS SUBTITLE AUTHORIZES A SPORTS WAGERING LICENSEE TO**
16 **CONDUCT AND OPERATE SPORTS WAGERING IN THE STATE AS PROVIDED IN THIS**
17 **SUBTITLE.**

18 **9-1E-03.**

19 **(A) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, THE COMMISSION**
20 **SHALL REGULATE SPORTS WAGERING AND THE CONDUCT OF SPORTS WAGERING TO**
21 **THE SAME EXTENT THAT THE COMMISSION REGULATES THE OPERATION OF VIDEO**
22 **LOTTERY TERMINALS AND TABLE GAMES UNDER SUBTITLE 1A OF THIS TITLE.**

23 **(B) IN ACCORDANCE WITH THIS SUBTITLE, THE COMMISSION SHALL ADOPT**
24 **REGULATIONS THAT ESTABLISH:**

25 **(1) THE FORM AND CONTENT OF AND THE DEADLINE TO SUBMIT AN**
26 **APPLICATION FOR ANY LICENSE REQUIRED UNDER THIS SUBTITLE;**

27 **(2) THE METHODS, PROCEDURES, AND FORM FOR DELIVERY OF**
28 **INFORMATION FROM AN APPLICANT OR A LICENSEE CONCERNING ANY PERSON’S**
29 **FAMILY, HABITS, CHARACTER, ASSOCIATES, CRIMINAL RECORD, BUSINESS**
30 **ACTIVITIES, AND FINANCIAL AFFAIRS;**

1 **(3) THE PROCEDURES FOR THE FINGERPRINTING OF AN APPLICANT**
2 **FOR ANY LICENSE REQUIRED UNDER THIS SUBTITLE OR OTHER METHODS OF**
3 **IDENTIFICATION THAT MAY BE NECESSARY IN THE JUDGMENT OF THE COMMISSION**
4 **TO ACCOMPLISH EFFECTIVE ENFORCEMENT OF THE PROVISIONS OF THIS SUBTITLE;**

5 **(4) APPLICATION AND RENEWAL FEES AS REQUIRED UNDER §**
6 **9-1E-06(C) OF THIS SUBTITLE;**

7 **(5) THE GROUNDS AND PROCEDURES FOR REPRIMANDS OF**
8 **LICENSEES OR THE REVOCATION OR SUSPENSION OF LICENSES ISSUED UNDER THIS**
9 **SUBTITLE;**

10 **(6) THE MANNER AND METHOD OF COLLECTION OF TAXES, FEES, AND**
11 **CIVIL PENALTIES;**

12 **(7) STANDARDS, PROCEDURES, AND RULES THAT GOVERN THE**
13 **CONDUCT OF SPORTS WAGERING, INCLUDING:**

14 **(I) DEFINING AND LIMITING THE AREAS OF OPERATION FOR**
15 **SPORTS WAGERING AND SPECIFYING THE SQUARE FOOTAGE, DESIGN, TYPE OF**
16 **EQUIPMENT, SECURITY MEASURES, AND ANY OTHER MATTER RELATING TO A**
17 **SPORTS WAGERING LOUNGE NECESSARY TO CARRY OUT THE PROVISIONS OF THIS**
18 **SUBTITLE;**

19 **(II) THE APPROVAL PROCESS FOR SELF-SERVICE KIOSKS OR**
20 **MACHINES, SECURITY MEASURES FOR THE KIOSKS OR MACHINES, THE AMOUNT OF**
21 **WAGERS AUTHORIZED ON THE KIOSKS OR MACHINES, AND ANY OTHER MATTER**
22 **RELATING TO A SELF-SERVICE KIOSK OR MACHINE NECESSARY TO CARRY OUT THE**
23 **PROVISIONS OF THIS SUBTITLE;**

24 **(III) THE TYPES OF WAGERS ON SPORTING EVENTS THAT MAY BE**
25 **ACCEPTED BY A SPORTS WAGERING LICENSEE;**

26 **(IV) THE TYPES AND VALUES OF PROMOTIONAL ITEMS THAT MAY**
27 **BE GIVEN AWAY TO ENCOURAGE SPORTS WAGERING;**

28 **(V) THE MANNER IN WHICH WAGERS ARE RECEIVED, PAYOUTS**
29 **ARE REMITTED, AND POINT SPREADS, LINES, AND ODDS ARE DETERMINED;**

30 **(VI) THE MAXIMUM WAGERS THAT MAY BE ACCEPTED BY A**
31 **SPORTS WAGERING LICENSEE OR ONLINE SPORTS WAGERING OPERATOR FROM A**
32 **SINGLE BETTOR ON A SINGLE SPORTING EVENT;**

1 (VII) THE AMOUNT OF CASH RESERVES TO BE MAINTAINED BY
2 SPORTS WAGERING LICENSEES TO COVER WINNING WAGERS;

3 (VIII) ACCEPTABLE FORMS OF PAYMENT AND ADVANCE DEPOSIT
4 METHODS BY BETTORS;

5 (IX) MINIMUM UNIFORM STANDARDS OF ACCOUNTANCY
6 METHODS, PROCEDURES, AND FORMS AS ARE NECESSARY TO ENSURE
7 CONSISTENCY, COMPARABILITY, AND EFFECTIVE DISCLOSURE OF ALL FINANCIAL
8 INFORMATION, INCLUDING PERCENTAGES OF PROFIT;

9 (X) PERIODIC FINANCIAL REPORTS AND THE FORM OF THE
10 REPORTS, INCLUDING AN ANNUAL AUDIT PREPARED BY A CERTIFIED PUBLIC
11 ACCOUNTANT LICENSED TO DO BUSINESS IN THE STATE, DISCLOSING WHETHER THE
12 ACCOUNTS, RECORDS, AND CONTROL PROCEDURES EXAMINED ARE MAINTAINED BY
13 THE SPORTS WAGERING LICENSEE AS REQUIRED BY THIS SUBTITLE AND THE
14 REGULATIONS THAT SHALL BE ISSUED UNDER THIS SUBTITLE;

15 (XI) REQUIRING LICENSEES UNDER THIS SUBTITLE TO
16 DEMONSTRATE AND MAINTAIN FINANCIAL VIABILITY; AND

17 (XII) ENSURING THAT SPORTS WAGERING IS CONDUCTED
18 LEGALLY; AND

19 (8) ANY OTHER REGULATION NECESSARY TO CARRY OUT THE
20 PROVISIONS OF THIS SUBTITLE.

21 9-1E-04.

22 (A) THE FOLLOWING PERSONS SHALL BE LICENSED UNDER THIS SUBTITLE:

23 (1) A VIDEO LOTTERY OPERATOR THAT OPERATES SPORTS
24 WAGERING;

25 (2) A PERSON THAT OPERATES SPORTS WAGERING ON BEHALF OF A
26 SPORTS WAGERING LICENSEE, INCLUDING AN ONLINE SPORTS WAGERING
27 OPERATOR;

28 (3) A PERSON NOT LICENSED UNDER ITEM (1) OR (2) OF THIS
29 SUBSECTION THAT MANAGES, OPERATES, SUPPLIES, PROVIDES SECURITY FOR, OR
30 PROVIDES SERVICE, MAINTENANCE, OR REPAIRS FOR SPORTS WAGERING
31 EQUIPMENT AND DEVICES; AND

1 (4) AN INDIVIDUAL EMPLOYED IN THE OPERATION OF SPORTS
2 WAGERING BY A SPORTS WAGERING LICENSEE IF THE INDIVIDUAL DOES NOT
3 OTHERWISE HOLD A VALID LICENSE UNDER SUBTITLE 1A OF THIS TITLE.

4 (B) THE COMMISSION MAY BY REGULATION REQUIRE A PERSON THAT
5 CONTRACTS WITH A LICENSEE AND THE PERSON'S EMPLOYEES TO OBTAIN A
6 LICENSE UNDER THIS SUBTITLE IF THE COMMISSION DETERMINES THAT THE
7 LICENSING REQUIREMENTS ARE NECESSARY IN ORDER TO PROTECT THE PUBLIC
8 INTEREST AND ACCOMPLISH THE POLICIES ESTABLISHED BY THIS SUBTITLE.

9 (C) FOR ALL LICENSES REQUIRED UNDER THIS SUBTITLE, IF AN APPLICANT
10 HOLDS A VALID LICENSE IN ANOTHER STATE AND THE COMMISSION DETERMINES
11 THAT THE LICENSING STANDARDS OF THE OTHER STATE ARE COMPREHENSIVE AND
12 THOROUGH AND PROVIDE SIMILAR AND ADEQUATE SAFEGUARDS TO THOSE
13 PROVIDED IN THIS SUBTITLE, THE COMMISSION MAY:

14 (1) WAIVE SOME OR ALL OF THE REQUIREMENTS OF THIS SUBTITLE;
15 AND

16 (2) ISSUE A LICENSE TO THAT APPLICANT.

17 (D) (1) ON THE REQUEST OF AN APPLICANT, THE COMMISSION MAY
18 GRANT AN EXEMPTION OR A WAIVER OF A LICENSING REQUIREMENT OR GROUNDS
19 FOR DENIAL OF A LICENSE IF THE COMMISSION DETERMINES THAT THE
20 REQUIREMENT OR GROUNDS FOR DENIAL OF A LICENSE AS APPLIED TO THE
21 APPLICANT ARE NOT NECESSARY TO PROTECT THE PUBLIC INTEREST OR
22 ACCOMPLISH THE POLICIES ESTABLISHED BY THIS SUBTITLE.

23 (2) ON GRANTING TO AN APPLICANT AN EXEMPTION OR A WAIVER
24 UNDER THIS SUBSECTION, OR AT ANY TIME AFTER A WAIVER OR AN EXEMPTION HAS
25 BEEN GRANTED, THE COMMISSION MAY:

26 (I) LIMIT OR PLACE RESTRICTIONS ON THE EXEMPTION OR
27 WAIVER AS THE COMMISSION CONSIDERS NECESSARY IN THE PUBLIC INTEREST;
28 AND

29 (II) REQUIRE THE PERSON THAT IS GRANTED THE EXEMPTION
30 OR WAIVER TO COOPERATE WITH THE COMMISSION AND TO PROVIDE THE
31 COMMISSION WITH ANY ADDITIONAL INFORMATION REQUIRED BY THE
32 COMMISSION AS A CONDITION OF THE WAIVER OR EXEMPTION.

1 (A) A VIDEO LOTTERY OPERATOR MAY APPLY TO THE COMMISSION FOR A
2 SPORTS WAGERING LICENSE.

3 (B) AN APPLICATION SUBMITTED FOR A SPORTS WAGERING LICENSE
4 UNDER THIS SECTION SHALL INCLUDE AN APPLICATION FEE OF \$2,500,000.

5 (C) A SPORTS WAGERING LICENSEE MAY NOT BEGIN ACCEPTING WAGERS
6 ON SPORTING EVENTS UNTIL THE FEE UNDER SUBSECTION (B) OF THIS SECTION IS
7 PAID IN FULL.

8 (D) THE TERM OF A SPORTS WAGERING LICENSE UNDER THIS SECTION IS 1
9 YEAR.

10 (E) ON APPLICATION BY THE SPORTS WAGERING LICENSEE AND
11 SUBMISSION OF A \$250,000 LICENSE RENEWAL FEE, THE COMMISSION MAY RENEW
12 FOR 1 YEAR A SPORTS WAGERING LICENSE.

13 **9-1E-06.**

14 (A) AN APPLICANT FOR A LICENSE UNDER THIS SUBTITLE SHALL SUBMIT TO
15 THE COMMISSION AN APPLICATION:

16 (1) IN THE FORM THAT THE COMMISSION REQUIRES; AND

17 (2) ON OR BEFORE THE DATE SET BY THE COMMISSION.

18 (B) AS A CONDITION TO THE COMMISSION'S APPROVAL OF A LICENSE
19 UNDER THIS SUBTITLE, THE APPLICANT SHALL SIGN A MEMORANDUM OF
20 UNDERSTANDING WITH THE COMMISSION THAT REQUIRES THE APPLICANT TO USE
21 BEST EFFORTS AND EFFECTIVE OUTREACH TO COMPLY, TO THE EXTENT
22 PRACTICABLE AND AUTHORIZED BY THE UNITED STATES CONSTITUTION, WITH THE
23 STATE'S MINORITY BUSINESS ENTERPRISE PROGRAM.

24 (C) (1) THIS SUBSECTION DOES NOT APPLY TO THE APPLICATION OR
25 LICENSE RENEWAL FEES FOR A SPORTS WAGERING LICENSE REQUIRED UNDER §
26 **9-1E-05** OF THIS SUBTITLE.

27 (2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE
28 COMMISSION SHALL ADOPT REGULATIONS THAT ESTABLISH AN APPLICATION FEE
29 AND LICENSE RENEWAL FEE FOR A LICENSE UNDER THIS SUBTITLE.

30 (II) THE APPLICATION FEE FOR AN ONLINE SPORTS WAGERING

1 OPERATOR LICENSE MAY NOT BE LESS THAN \$5,000.

2 (3) AN APPLICANT SHALL SUBMIT THE APPLICATION FEE WITH THE
3 APPLICATION.

4 (4) THE TERM OF THE LICENSE IS 1 YEAR.

5 (D) ON A PROPERLY APPROVED TRANSMITTAL PREPARED BY THE
6 COMMISSION, THE COMPTROLLER SHALL PAY THE APPLICATION FEES AND LICENSE
7 RENEWAL FEES COLLECTED BY THE COMMISSION UNDER THIS SECTION AND §
8 9-1E-05 OF THIS SUBTITLE TO THE EDUCATION TRUST FUND ESTABLISHED UNDER
9 § 9-1A-30 OF THIS TITLE.

10 (E) (1) APPLICANTS AND LICENSEES SHALL HAVE THE AFFIRMATIVE
11 RESPONSIBILITY TO ESTABLISH BY CLEAR AND CONVINCING EVIDENCE THE
12 APPLICANT'S OR LICENSEE'S QUALIFICATIONS.

13 (2) APPLICANTS AND LICENSEES SHALL PROVIDE INFORMATION
14 REQUIRED BY THIS SUBTITLE AND SATISFY REQUESTS FOR INFORMATION RELATING
15 TO QUALIFICATIONS IN THE FORM SPECIFIED BY THE COMMISSION, IF APPLICABLE.

16 (3) (I) APPLICANTS AND LICENSEES SHALL:

17 1. PROVIDE ASSISTANCE OR INFORMATION REQUIRED
18 BY THE COMMISSION; AND

19 2. COOPERATE IN AN INQUIRY, AN INVESTIGATION, OR A
20 HEARING CONDUCTED BY THE COMMISSION.

21 (II) ON ISSUANCE OF A FORMAL REQUEST TO ANSWER OR
22 PRODUCE INFORMATION, EVIDENCE, OR TESTIMONY, IF AN APPLICANT OR A
23 LICENSEE REFUSES TO COMPLY, THE APPLICATION OR LICENSE MAY BE DENIED,
24 SUSPENDED, OR REVOKED BY THE COMMISSION.

11 shall be submitted to a referendum of the qualified voters of the State at the general
12 election to be held in November 2020, in accordance with Article XIX, § 1(e) of the Maryland
13 Constitution. The State Board of Elections shall do those things necessary and proper to
14 provide for and hold the referendum required by this section. If a majority of the votes cast
15 on the question are “For the referred law”, this Act shall become effective on the 30th day
16 following the official canvass of votes for the referendum, but if a majority of the votes cast
17 on the question are “Against the referred law”, this Act, with no further action required by
18 the General Assembly, shall be null and void.

19 SECTION 4. AND BE IT FURTHER ENACTED, That, subject to the provisions of
20 Section 3 of this Act and for the sole purpose of providing for the referendum required by
21 Section 3 of this Act, this Act shall take effect July 1, 2020.
