A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Rental Vehicles – Driver’s License Verification and Records**

3 FOR the purpose of prohibiting a vehicle lessor from renting a vehicle to another person
4 unless the lessor verifies that the person’s driver’s license is not expired; authorizing
5 a vehicle lessor to inspect a driver’s license of a vehicle lessee through electronic or
6 digital means under certain circumstances; authorizing a vehicle lessor to keep
7 certain records in an electronic or digital format; establishing that a vehicle lessor
8 that rents a vehicle to another person in a certain manner is deemed to have met
9 certain driver’s license verification requirements under certain circumstances; and
10 generally relating to verification of driver’s licenses and records for rental vehicles.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Transportation**

19 18–103.

20 (a) A person may not rent a motor vehicle, trailer, or semitrailer to any other
21 person unless the individual who will operate the rented vehicle:

22 (1) Holds a driver’s license issued under Title 16 of this article, which
23 license authorizes him to drive or tow, as the case may be, vehicles of the class rented;

24 (2) Is a nonresident who:

1 (i) Has with him a license to drive issued to him by the state or
2 country of his residence, which license authorizes him in that state or country to drive or
3 tow, as the case may be, vehicles of the class rented; and

4 (ii) Is at least the same age as that required of a resident to drive or
5 tow, as the case may be, the vehicle rented; or

6 (3) Otherwise is specifically authorized by Title 16 of this article to drive
7 or tow, as the case may be, vehicles of the class rented.

8 (b) (1) A person may not rent a motor vehicle, trailer, or semitrailer to any
9 other person unless the lessor or his agent:

10 [(1)] (I) Has inspected the license to drive of the individual who will
11 operate the rented vehicle; [and]

12 [(2)] (II) Has compared and verified:

13 [(i)] 1. The signature on the license with the signature of the
14 individual, as written in the presence of the lessor or agent; and

15 [(ii)] 2. The physical description on the license with the physical
16 appearance of the individual; AND

17 (III) HAS VERIFIED THAT THE LICENSE IS NOT EXPIRED.

18 (2) AN INSPECTION OF A LICENSE UNDER THIS SECTION MAY BE
19 THROUGH ELECTRONIC OR DIGITAL MEANS.

20 (c) (1) Each person who rents a motor vehicle, trailer, or semitrailer to another
21 person shall keep a record of:

22 [(1)] (I) The registration number of the rented vehicle and, if only a
23 semitrailer or trailer is rented, the registration number of the motor vehicle to be used to
24 tow the trailer or semitrailer;

25 [(2)] (II) The name and address of the lessee;

26 [(3)] (III) The number of the license to drive of the individual who will drive
27 or tow, as the case may be, the rented vehicle; and

28 [(4)] (IV) The date and place of issuance of the license to drive.

29 (2) RECORDS MAY BE KEPT UNDER THIS SUBSECTION IN AN

1 **ELECTRONIC OR DIGITAL FORMAT.**

2 (d) Any police officer or authorized representative of the Administration may
3 inspect the records kept under subsection (c) of this section.

4 (E) IF A LESSOR RENTS A MOTOR VEHICLE, TRAILER, OR SEMITRAILER TO
5 ANOTHER PERSON IN A MANNER THAT ALLOWS THE OTHER PERSON TO OBTAIN
6 POSSESSION OF THE RENTED VEHICLE WITHOUT MAKING DIRECT CONTACT WITH
7 THE LESSOR, THE LESSOR SHALL BE DEEMED TO HAVE MET THE REQUIREMENTS OF
8 SUBSECTIONS (A) AND (B) OF THIS SECTION IF THE LESSOR REQUIRES THE PERSON
9 WHO WILL OPERATE THE RENTED VEHICLE TO ENTER INTO A MEMBERSHIP OR
10 MASTER PROGRAM AGREEMENT.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2020.
