A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Equipment – Safety Glass – Replacement Standards**

3 FOR the purpose of requiring the Motor Vehicle Administration to adopt regulations
4 establishing standards and requirements for aftermarket safety glass replacement
5 that meet or exceed the standards and requirements under the Automotive Glass
6 Replacement Safety Standard established by the Auto Glass Safety Council; and
7 generally relating to standards and requirements for replacement automotive safety
8 glass.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Transportation**

22 22–406.

23 (a) “Safety glass” means:

24 (1) Any glass product that is so made or treated as substantially to prevent

1 the glass from shattering and flying when struck or broken; or

2 (2) Any similar or other product that the Administration approves.

3 (d) The owner of any motor vehicle may not have broken glass in the windshield
4 of the vehicle replaced with any glass other than safety glass.

5 (e) The owner of any motor vehicle may not have safety glass, broken or
6 otherwise, in doors, windows, or wings of the motor vehicle replaced with any glass other
7 than safety glass.

8 (f) A person may not install in the doors, windows, windshields, and wings of any
9 motor vehicle any glass other than glass required by subsections (d) and (e) of this section.

10 (g) (1) (I) The Administration shall compile, maintain, and publish a list,
11 by name, of the types of glass approved by it as conforming to the specifications and
12 requirements of safety glass as set forth in this section.

13 (II) **THE ADMINISTRATION SHALL ADOPT REGULATIONS**
14 **ESTABLISHING STANDARDS AND REQUIREMENTS FOR AFTERMARKET SAFETY GLASS**
15 **REPLACEMENT THAT MEET OR EXCEED THE STANDARDS AND REQUIREMENTS**
16 **UNDER THE AUTOMOTIVE GLASS REPLACEMENT SAFETY STANDARD ESTABLISHED**
17 **BY THE AUTO GLASS SAFETY COUNCIL.**

18 (2) The Administration may not register any motor vehicle that is subject
19 to the provisions of this section unless it is equipped with an approved type of safety glass
20 and shall suspend the registration of any motor vehicle subject to this section that the
21 Administration finds is not so equipped until the vehicle is made to conform to the
22 requirements of this section.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2021.
