RE: SB 427 – Baltimore County – Hunting – Deer Management Permits

Dear Chairman Pinsky and Members of the Committee:

I am pleased to introduce Senate Bill 427 which will authorize an individual who hunts under a Deer Management Permit in Baltimore County to use a shotgun or breech loading center rifle to hunt deer throughout the year, including all deer seasons, at the locations leased or owned by the individual or locations specified on the permit. Baltimore County would simply be added to the existing list of Maryland counties that participate in these deer management practices.

This bill was heard in the Baltimore County Senate Delegation and received a favorable vote. I have attached the corresponding letter.
