AMENDMENT NO. 1

On page 2, strike in their entirety lines 1 through 5, inclusive, and substitute:

“(I) A HOSPITAL AS DEFINED IN § 19-301 OF THE HEALTH – GENERAL ARTICLE;

(II) A RELATED INSTITUTION AS DEFINED IN § 19-301 OF THE HEALTH – GENERAL ARTICLE;

(III) A MEDICAL DAY CARE CENTER;

(IV) A HOSPICE PROGRAM;

(V) AN ASSISTED LIVING PROGRAM;

(VI) A FREESTANDING AMBULATORY CARE FACILITY AS DEFINED IN § 19-3B-01 OF THE HEALTH – GENERAL ARTICLE; AND

(VII) THE FOLLOWING INDIVIDUALS LICENSED UNDER THE HEALTH OCCUPATIONS ARTICLE OR AUTHORIZED TO PROVIDE ONE OR MORE HEALTH SERVICES IN THE STATE;

AMENDMENT NO. 2

On page 2, strike beginning with the comma in line 6 down through the comma in line 7.

AMENDMENT NO. 3

On page 2, strike in their entirety lines 9 through 13, inclusive, and substitute:

“(I) A HOSPITAL AS DEFINED IN § 19-301 OF THE HEALTH – GENERAL ARTICLE;

(II) A RELATED INSTITUTION AS DEFINED IN § 19-301 OF THE HEALTH – GENERAL ARTICLE;

(III) A MEDICAL DAY CARE CENTER;

(IV) A HOSPICE PROGRAM;

(V) AN ASSISTED LIVING PROGRAM;

(VI) A FREESTANDING AMBULATORY CARE FACILITY AS DEFINED IN § 19-3B-01 OF THE HEALTH – GENERAL ARTICLE; OR

(VII) AN INDIVIDUAL LISTED IN PARAGRAPH (1)(VII) OF THIS SUBSECTION.”.
