AMENDMENTS TO SENATE BILL 748  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Waters of the State” and substitute “Limiting Applicability”; in line 3, strike beginning with “altering” through the fourth “the” and substitute “specifying that certain”; in line 5, after “Agriculture” insert “apply to certain surface waters, the Chesapeake Bay and its tributaries, and other certain bodies of water”; strike in their entirety lines 6 through 10, inclusive; in line 13, strike “8-801(n)” and substitute “8-803.4(e) and 8-803.5(d)”; in line 20, strike “(e) and”; in the same line, strike “and (d)”; and after line 24, insert:

“BY repealing and reenacting, with amendments,

Article – Agriculture

Section 8-803.6(a)

Annotated Code of Maryland

(2007 Replacement Volume and 2012 Supplement)”.

AMENDMENT NO. 2

On page 2, strike in their entirety lines 2 through 12, inclusive.

AMENDMENT NO. 3

On page 2 in line 16 and on page 3 in line 16, in each instance, strike “waters of the State” and substitute “:

**(I) SURFACE WATER SUBJECT TO THE JURISDICTION OF THE STATE;**

**(II) THE CHESAPEAKE BAY AND ITS TRIBUTARIES;**

(Over)

(III) A POND WITHIN THE STATE;

(IV) A LAKE WITHIN THE STATE;

(V) A RIVER WITHIN THE STATE;

(VI) A STREAM WITHIN THE STATE;

(VII) A PUBLIC DITCH WITHIN THE STATE;

(VIII) A TAX DITCH WITHIN THE STATE; OR

(IX) A PUBLIC DRAINAGE SYSTEM WITHIN THE STATE, OTHER THAN THOSE DESIGNED AND USED TO COLLECT, CONVEY, OR DISPOSE OF SANITARY SEWAGE”.

On page 4, in line 2, strike “the waters of the State” and substitute “:

1. SURFACE WATER SUBJECT TO THE JURISDICTION OF THE STATE;
2. THE CHESAPEAKE BAY AND ITS TRIBUTARIES;
3. A POND WITHIN THE STATE;
4. A LAKE WITHIN THE STATE;
5. A RIVER WITHIN THE STATE;
6. A STREAM WITHIN THE STATE;

7. A PUBLIC DITCH WITHIN THE STATE;
8. A TAX DITCH WITHIN THE STATE; AND
9. A PUBLIC DRAINAGE SYSTEM WITHIN THE STATE, OTHER THAN THOSE DESIGNED AND USED TO COLLECT, CONVEY, OR DISPOSE OF SANITARY SEWAGE”.

AMENDMENT NO. 4

On page 4, strike in their entirety lines 11 through 15, inclusive; in line 17, after the first “of” insert “Sections 4 and 5 of”; in line 18, after the second “of” insert “Sections 4 and 5 of”; and in line 19, after “of” insert “Sections 4 and 5 of”.
