A BILL ENTITLED

1 AN ACT concerning

2 **Alcoholic Beverages – Queen Anne’s County – Beer and Wine Festivals**

3 FOR the purpose of authorizing the Queen Anne’s County Board of License
4 Commissioners to issue a certain number of Beer and Wine Festival (BWF)
5 licenses in the county each year; authorizing the Board to select a certain
6 number of weekends each year for a certain festival; requiring the Board to
7 choose a certain location for a certain festival and to ensure that the primary
8 focus of a certain festival is the promotion of certain beer and wine; altering a
9 certain definition; making a technical correction; and generally relating to beer
10 and wine festivals in Queen Anne’s County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article 2B – Alcoholic Beverages**

19 8–311.

20 (a) (1) In this section the following words have the meanings indicated.

21 (2) “Board” means the Queen Anne’s County Board of License
22 Commissioners.

1 (3) “Festival” means [the Queen Anne’s County Beer and Wine
2 Festival (QABWF)] **A BEER AND WINE FESTIVAL (BWF) IN QUEEN ANNE’S**
3 **COUNTY.**

4 (b) This section applies only in Queen Anne’s County.

5 (c) The Board may issue a special festival license.

6 (d) Notwithstanding any other provision of this article, an applicant for a
7 special festival license shall be a holder of an existing State retail alcoholic beverages
8 license, State Class 3 winery license, or State Class 4 limited winery license issued
9 under this article.

10 (e) A special festival licensee shall:

11 (1) Only display and sell:

12 (i) Wine that is:

13 1. Manufactured and processed in any state;

14 2. Price filed in accordance with regulations adopted by
15 the Comptroller; and

16 3. Distributed in the State at the time the application is
17 filed; and

18 (ii) Beer that is brewed by a brewer:

19 1. Who brews less than 60,000 barrels of beer annually;
20 and

21 2. Whose product is distributed in the State at the time
22 the application is filed;

23 (2) Display and sell beer and wine at retail for consumption on or off
24 the licensed premises on the days and for the hours designated for the Festival; and

25 (3) Display and sell wine that is manufactured and processed in any
26 state at retail for consumption off the licensed premises on the days and for the hours
27 designated for the Festival.

28 (f) This section does not prohibit the holder of a special festival license from
29 holding another alcoholic beverages license of a different class or nature.

30 (g) The Board:

1 (1) May establish the license fee;

2 (2) May select [one weekend] **A MAXIMUM OF 4 WEEKENDS EACH**
3 **YEAR**, Friday through Sunday inclusive, [annually] for [the] A Festival provided that
4 the weekend that is selected does not occur within 14 days on either side of the
5 Maryland Wine Festival;

6 (3) Shall choose a location in the county for [this] A Festival which is
7 not licensed under this article; and

8 (4) Shall [assure] **ENSURE** that the primary focus of [the] A Festival
9 is the promotion of Maryland beer and wine.

10 (h) (1) Products displayed and sold shall be:

11 (i) Invoiced to the festival license holder by a licensed State
12 wholesaler, winery, or limited winery; and

13 (ii) Delivered to the Festival from the licensed premises of the
14 wholesaler, winery, or limited winery.

15 (2) Whenever a festival license is issued pursuant to this subsection,
16 holders of wholesale, winery, or limited winery licenses may enter into an agreement
17 with the holder of a festival license to deliver beer and wine 2 days prior to the
18 effective date, and to accept returns 2 days after the expiration date of the festival
19 license.

20 (i) The Board shall adopt regulations for implementing this section.

21 **SECTION 2. AND BE IT FURTHER ENACTED**, That this Act shall take effect
22 July 1, 2013.
