1 AN ACT concerning

2 **Insurance Producers – Continuing Education – Online Courses**

3 FOR the purpose of prohibiting the Maryland Insurance Commissioner from
4 disapproving a continuing education course for insurance producers solely on a
5 certain basis; authorizing insurance producers to obtain all or part of the credit
6 hours of continuing education required for license renewal from correspondence
7 courses or online courses approved by the Commissioner; providing for the
8 application of certain provisions of this Act; and generally relating to continuing
9 education for insurance producers.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

3 (d) **(1)** The Commissioner may review all continuing education courses
4 submitted and approve or disapprove courses.

5 **(2) THE COMMISSIONER MAY NOT DISAPPROVE A CONTINUING**
6 **EDUCATION COURSE SOLELY ON THE BASIS OF THE METHODOLOGY OR**
7 **TECHNOLOGY USED TO DELIVER INSTRUCTION TO INDIVIDUALS TAKING THE**
8 **COURSE.**

9 **(D–1) (1) AN INSURANCE PRODUCER MAY OBTAIN ALL OR PART OF THE**
10 **CREDIT HOURS OF CONTINUING EDUCATION REQUIRED FOR RENEWAL OF A**
11 **LICENSE UNDER THIS SECTION FROM CORRESPONDENCE COURSES OR ONLINE**
12 **COURSES APPROVED BY THE COMMISSIONER.**

13 **(2) THIS SUBSECTION APPLIES TO ALL INSURANCE PRODUCERS**
14 **WHO ARE REQUIRED TO RECEIVE CONTINUING EDUCATION AS A CONDITION OF**
15 **LICENSE RENEWAL UNDER THIS SECTION, REGARDLESS OF THE KIND OR**
16 **SUBDIVISION OF INSURANCE FOR WHICH THE INSURANCE PRODUCER HAS**
17 **RECEIVED A LICENSE.**

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2013.
