## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Baltimore City –**  
3 **Assisted Living on the Green**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006  
5 to provide that a certain grant for the Assisted Living on the Green project may  
6 not terminate before a certain date; and generally relating to amending the  
7 Maryland Consolidated Capital Bond Loan of 2006.

8 BY repealing and reenacting, with amendments,  
9 Chapter 46 of the Acts of the General Assembly of 2006  
10 Section 1(3) Item ZA01(Q) and Item ZA02(V)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Chapter 46 of the Acts of 2006**

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
15 MARYLAND, That:

16 (3) ZA01 LOCAL SENATE INITIATIVES

17 (Q) Assisted Living on the Green. Provide a grant equal to the  
18 lesser of (i) \$200,000 or (ii) the amount of the matching fund  
19 provided, to the Board of Directors of GS Housing, Inc. for the  
20 planning, design, construction, and capital equipping of an  
21 assisted living facility for low-income individuals, to be  
22 located on the campus of The Good Samaritan Hospital in  
23 Baltimore City. **NOTWITHSTANDING SECTION 1(7) OF THIS**  
24 **ACT, THIS GRANT MAY NOT TERMINATE BEFORE JUNE 1,**

11           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
12          June 1, 2013.
