A BILL ENTITLED

1 AN ACT concerning

2 **Chesapeake College – Board of Trustees – Appointment of Members**

3 FOR the purpose of requiring the Governor to appoint the members of the Board of
4 Trustees of Chesapeake College from a list of at least a certain number of
5 qualified individuals submitted to the Governor by each county that supports
6 Chesapeake College; and generally relating to the appointment of the members
7 of the Board of Trustees of Chesapeake College.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Education**

16 16–406.

17 (a) (1) The Board of Trustees of Chesapeake College consists of two
18 members from each county that supports Chesapeake College who shall be appointed
19 by the Governor, with the advice and consent of the House of Delegates, **FROM A LIST**
20 **OF AT LEAST THREE QUALIFIED INDIVIDUALS SUBMITTED TO THE GOVERNOR**
21 **BY EACH COUNTY THAT SUPPORTS CHESAPEAKE COLLEGE.**

22 (2) The county superintendents of schools in the region are not ex
23 officio members.

- 1 (b) (1) (i) The term of a member is 5 years and begins on July 1.
- 2 (ii) A member continues to serve until a successor is appointed
3 and qualifies.
- 4 (2) (i) Subject to subparagraph (ii) of this paragraph, a member
5 appointed to begin a full term on or after July 1, 2006, may not serve for more than
6 three 5-year full terms.
- 7 (ii) A term of a member that began before July 1, 2006, does not
8 count toward the term limit established in subparagraph (i) of this paragraph.
- 9 (c) Each member of the Board:
- 10 (1) Serves without compensation; and
- 11 (2) Is entitled to reimbursement for expenses in accordance with
12 applicable travel regulations.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 June 1, 2013.
