A BILL ENTITLED

1 AN ACT concerning

2 **Slot Machines – Ownership and Operation by War Veterans’ Organizations –**
3 **Allocation of Proceeds**

4 FOR the purpose of making provisions that authorize eligible war veterans’
5 organizations to operate slot machines applicable statewide; altering the
6 definition of “eligible organization” to make it applicable to a war veterans’
7 organization that has been located in the State for a certain number of years
8 before the organization applies for a license for a slot machine; authorizing an
9 eligible organization to own and operate a slot machine if the eligible
10 organization owns or leases each slot machine that it operates and does not own
11 or lease more than a certain number of slot machines; specifying the manner in
12 which certain proceeds from the slot machines of war veterans’ organizations
13 located in certain counties are to be used; and generally relating to slot machine
14 ownership and operation by eligible war veterans’ organizations.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Criminal Law**

23 12–304.

24 (a) In this section, “eligible organization” means:

1 **(1) A BONA FIDE WAR VETERANS' ORGANIZATION THAT HAS BEEN**
2 **LOCATED IN THE STATE FOR AT LEAST 5 YEARS BEFORE THE ORGANIZATION**
3 **APPLIES FOR A LICENSE UNDER SUBSECTION (F) OF THIS SECTION;**

4 **[(1)] (2)** a nonprofit organization that:

5 (i) has been located in a county listed in subsection (b) of this
6 section for at least 5 years before the organization applies for a license under
7 subsection **[(e)] (F)** of this section; and

8 (ii) is a bona fide:

- 9 1. fraternal organization;
- 10 2. religious organization; or
- 11 3. war veterans' organization; or

12 **[(2)] (3)** a nonprofit organization that has been affiliated with a
13 national fraternal organization for less than 5 years and has been located in a county
14 listed in subsection (b) of this section for at least 50 years before the nonprofit
15 organization applies for a license under subsection **[(e)] (F)** of this section.

16 (b) **(1)** This section applies **[in] ON A STATEWIDE BASIS TO AN**
17 **ELIGIBLE ORGANIZATION DESCRIBED IN SUBSECTION (A)(1) OF THIS SECTION.**

18 **(2) THIS SECTION APPLIES TO AN ELIGIBLE ORGANIZATION**
19 **DESCRIBED IN SUBSECTION (A)(2) OR (3) OF THIS SECTION ONLY IF THE**
20 **ELIGIBLE ORGANIZATION IS LOCATED IN:**

- 21 **[(1)] (I)** Caroline County;
- 22 **[(2)] (II)** Cecil County;
- 23 **[(3)] (III)** Dorchester County;
- 24 **[(4)] (IV)** Kent County;
- 25 **[(5)] (V)** Queen Anne's County;
- 26 **[(6)] (VI)** Somerset County;
- 27 **[(7)] (VII)** Talbot County;
- 28 **[(8)] (VIII)** Wicomico County; and

1 ~~[(9)]~~ **(IX)** Worcester County.

2 (c) (1) In this subsection, a console or set of affixed slot machines is not
3 an individual slot machine.

4 (2) Notwithstanding any other provision of this subtitle, an eligible
5 organization may ~~[own and]~~ operate a slot machine if the eligible organization:

6 (i) obtains a license under subsection ~~[(e)]~~ **(F)** of this section for
7 each slot machine;

8 (ii) owns **OR LEASES** each slot machine that the eligible
9 organization operates;

10 (iii) owns **OR LEASES** not more than five slot machines;

11 (iv) locates and operates its slot machines at its principal
12 meeting hall in the county in which the eligible organization is located;

13 (v) does not locate or operate its slot machines in a private
14 commercial facility;

15 (vi) **EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS**
16 **SECTION**, uses:

17 1. at least one-half of the ~~[net after payout]~~ proceeds
18 from its slot machines for the benefit of a charity; and

19 2. the remainder of the proceeds from its slot machines
20 to further the purposes of the eligible organization;

21 (vii) does not use any of the proceeds of the slot machine for the
22 financial benefit of an individual; and

23 (viii) reports annually under affidavit to the State Comptroller:

24 1. the income of each slot machine; and

25 2. the disposition of the income from each slot machine.

26 **(D) A WAR VETERANS' ORGANIZATION AS DESCRIBED IN SUBSECTION**
27 **(A)(1) OF THIS SECTION THAT IS LOCATED IN A COUNTY NOT LISTED IN**
28 **SUBSECTION (B) OF THIS SECTION SHALL USE THE NET AFTER PAYOUT**
29 **PROCEEDS FROM ITS SLOT MACHINES IN THE FOLLOWING MANNER:**

1 **(1) 50% TO FURTHER THE PURPOSES OF THE WAR VETERANS'**
2 **ORGANIZATION;**

3 **(2) 20% TO ONE OR MORE CHARITABLE ORGANIZATIONS**
4 **LOCATED IN THE SAME COUNTY AS THE WAR VETERANS' ORGANIZATION;**

5 **(3) 15% TO THE GENERAL FUND OF THE STATE; AND**

6 **(4) (I) 15% TO THE GENERAL FUND OF THE COUNTY IN WHICH**
7 **THE WAR VETERANS' ORGANIZATION IS LOCATED; OR**

8 **(II) IF THE WAR VETERANS' ORGANIZATION IS LOCATED IN A**
9 **MUNICIPAL CORPORATION, 7.5% TO THE GENERAL FUND OF THE MUNICIPAL**
10 **CORPORATION AND 7.5 % TO THE GENERAL FUND OF THE COUNTY.**

11 **[(d)] (E)** An eligible organization may not use or operate a slot machine
12 unless:

13 (1) the slot machine is equipped with a tamperproof meter or counter
14 that accurately records gross receipts; and

15 (2) the eligible organization keeps an accurate record of the gross
16 receipts and payoffs of the slot machine.

17 **[(e)] (F)** (1) (i) The State Comptroller shall regulate the operation of
18 slot machines under this section.

19 (ii) The State Comptroller may adopt regulations to implement
20 the requirements of this section, including requiring audits of the annual reports
21 submitted to the State Comptroller under subsection (c)(2)(viii) of this section.

22 (2) Before an eligible organization may operate a slot machine under
23 this section, the eligible organization shall obtain a license for the slot machine from
24 the State Comptroller.

25 (3) (i) The State Comptroller shall:

26 1. charge an annual fee for each license for a machine;

27 and

28 2. issue a license sticker to the applicant.

29 (ii) The applicant shall place the sticker on the slot machine.

30 (iii) The State Comptroller shall set the amount of the annual
31 fee so that the total proceeds of the annual fee equal an amount directly related to

1 administrative costs of the State Comptroller to regulate the operation of slot
2 machines under this section.

3 (4) In the application to the State Comptroller for a license, one of the
4 principal officers of the eligible organization shall certify under affidavit that the
5 organization:

6 (i) is an eligible organization; and

7 (ii) will comply with this section.

8 **[(f)] (G)** (1) A principal officer of the eligible organization may not
9 intentionally misrepresent a statement of fact on the application.

10 (2) A person who violates this subsection is guilty of perjury and on
11 conviction is subject to the penalty provided under Title 9, Subtitle 1 of this article.

12 **[(g)] (H)** The Comptroller may not issue a license for a slot machine to an
13 eligible organization located in Ocean City that is located east of South and North
14 Baltimore Avenues.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 July 1, 2014.
