1 AN ACT concerning

2 **Anne Arundel County – Sheriff – Salary Increases**

3 FOR the purpose of altering the annual salary of the Sheriff of Anne Arundel County
4 for certain calendar years; ~~requiring that beginning with a certain calendar year~~
5 repealing a certain requirement that the annual salary of the Sheriff equal the
6 salary of a captain in the Anne Arundel County Police Department at a certain
7 rate in the pay scale; providing that this Act does not apply to the salary or
8 compensation of the Sheriff while serving in a certain term of office; providing
9 that a certain limitation does not apply to a certain individual; and generally
10 relating to the salary of the Sheriff of Anne Arundel County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article – Courts and Judicial Proceedings**

19 2–309.

1 (c) (1) The ANNUAL SALARY OF THE Sheriff of Anne Arundel County
2 shall [receive a salary equal] BE:

3 (I) ~~\$128,000~~ \$128,657 FOR CALENDAR YEAR 2014; AND

4 (II) ~~\$135,680~~ \$133,000 FOR CALENDAR YEAR 2015; AND
5 EACH SUBSEQUENT CALENDAR YEAR.

6 ~~(III) INCREASED BY 2% EACH YEAR FOR CALENDAR YEARS~~
7 ~~2016, 2017, AND 2018; AND~~

8 ~~(IV) EQUAL to the salary of a captain in the Anne Arundel~~
9 ~~County Police Department at the highest rate in the pay scale FOR CALENDAR YEAR~~
10 ~~2019 AND EACH SUBSEQUENT CALENDAR YEAR.~~

11 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
12 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
13 the salary or compensation of the Sheriff of Anne Arundel County while serving in a
14 term of office beginning before the effective date of this Act, but the provisions of this
15 Act concerning the salary or compensation of the Sheriff of Anne Arundel County shall
16 take effect at the beginning of the next following term of office. This limitation does
17 not apply to an individual appointed or elected after the effective date of this Act to fill
18 out an unexpired term.

19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 October 1, 2014.
