WHEREAS, On February 27, 1861, in an attempt to avert the secession of Southern states, United States Representative Thomas Corwin of Ohio proposed an amendment to the United States Constitution that would prohibit the United States Constitution from being amended in a manner that authorizes Congress to abolish or interfere with the states' domestic institutions, including slavery; and WHEREAS, On March 2, 1861, the Corwin Amendment passed the United States Congress and was submitted to the states for ratification; and WHEREAS, With the enactment of Chapter 21 of the Acts of 1862, the General Assembly of Maryland ratified the Corwin Amendment; and WHEREAS, The Corwin Amendment has not been ratified by three-fourths of the states and, therefore, is not part of the United States Constitution; and WHEREAS, With the end of the Civil War and the ratification of the 13th Amendment to the United States Constitution, the purposes of the Corwin Amendment have become moot; now, therefore, be it
