CHAPTER _____

1 AN ACT concerning

2 **State Lottery – Online Ticket Sales – Moratorium ~~and Study~~**

3 FOR the purpose of prohibiting the State Lottery and Gaming Control Agency from
4 allowing a person to purchase a State lottery ticket through an electronic device
5 that connects to the Internet; ~~establishing the Task Force to Study the Online~~
6 ~~Sale of State Lottery Tickets; providing for the composition, chair, and staffing~~
7 ~~of the Task Force; prohibiting a member of the Task Force from receiving~~
8 ~~certain compensation, but authorizing the reimbursement of certain expenses;~~
9 ~~requiring the Task Force to study and make determinations regarding certain~~
10 ~~matters; requiring the Task Force to report its findings, determinations, and~~
11 ~~any recommendations to the Governor and the General Assembly on or before a~~
12 ~~certain date; providing for the termination of this Act; and generally relating to~~
13 a moratorium on ~~and study of~~ the sale of State lottery tickets over the Internet.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That:

16 ~~(a)~~ The State Lottery and Gaming Control Agency may not allow a person to
17 purchase a State lottery ticket through an electronic device that connects to the
18 Internet, such as a personal computer or mobile device.

19 ~~(b) There is a Task Force to Study the Online Sale of State Lottery Tickets.~~

4 ~~(2) four members of the House of Delegates, appointed by the Speaker~~
5 ~~of the House;~~

6 ~~(3) the Director of the State Lottery and Gaming Control Agency, or~~
7 ~~the Director's designee;~~

8 ~~(4) a representative of the retail industry, appointed by the Governor;~~
9 ~~and~~

10 ~~(5) a representative from the Maryland Center of Excellence on~~
11 ~~Problem Gambling, appointed by the Director of the State Lottery and Gaming Control~~
12 ~~Agency.~~

13 ~~(d) The Governor shall designate the chair of the Task Force.~~

14 ~~(e) The State Lottery and Gaming Control Agency shall provide staff for the~~
15 ~~Task Force.~~

16 ~~(f) A member of the Task Force:~~

17 ~~(1) may not receive compensation as a member of the Task Force; but~~

18 ~~(2) is entitled to reimbursement for expenses under the Standard~~
19 ~~State Travel Regulations, as provided in the State budget.~~

20 ~~(g) The Task Force shall:~~

21 ~~(1) study:~~

22 ~~(i) the social impact of selling State lottery tickets over the~~
23 ~~Internet, including the consideration of safeguards for the public and underage~~
24 ~~residents;~~

25 ~~(ii) the financial impact on brick and mortar retailers from the~~
26 ~~sale of State lottery tickets over the Internet; and~~

27 ~~(iii) how other states that have authorized the sale of lottery~~
28 ~~tickets over the Internet have implemented their programs; and~~

29 ~~(2) determine if it is in the best interest of the State to authorize the~~
30 ~~sale of State lottery tickets over the Internet.~~

1 ~~(h) If the Task Force determines that it is in the best interest of the State to~~
2 ~~authorize the sale of State lottery tickets over the Internet, the Task Force shall make~~
3 ~~recommendations regarding:~~

4 ~~(1) best practices for establishing a program to sell State lottery~~
5 ~~tickets over the Internet;~~

6 ~~(2) necessary safeguards and protections for the public and underage~~
7 ~~residents; and~~

8 ~~(3) equitable treatment for brick and mortar retailers that sell State~~
9 ~~lottery tickets.~~

10 ~~(i) On or before January 1, 2015, the Task Force shall report its findings,~~
11 ~~determinations, and any recommendations to the Governor and, in accordance with §~~
12 ~~2-1246 of the State Government Article, the General Assembly.~~

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 July 1, 2014. It shall remain effective for a period of 1 year and, at the end of June 30,
15 2015, with no further action required by the General Assembly, this Act shall be
16 abrogated and of no further force and effect.
