A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Inspection Certificates for Used Vehicles – Procedures**

3 FOR the purpose of repealing the requirement that the Automotive Safety
4 Enforcement Division of the Department of State Police prepare certain
5 inspection certificates for used motor vehicles and provide the certificates
6 without charge to licensed motor vehicle inspection stations; requiring the
7 Division to establish the manner and format for the submission of an inspection
8 certificate for the transfer of a used motor vehicle; authorizing the Division to
9 require electronic submission of an inspection certificate for a used motor
10 vehicle; repealing certain provisions of law governing the issuance and use of
11 written inspection certificates for used motor vehicles; altering a certain
12 definition; making a certain technical correction; and generally relating to
13 procedures applicable to inspection certificates for used motor vehicles.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
7 MARYLAND, That the Laws of Maryland read as follows:

8 **Article – Transportation**

9 23–101.

10 (a) In this subtitle the following words have the meanings indicated.

11 (b) “Division” means the Automotive Safety Enforcement Division of the
12 Department of State Police.

13 (e) “Inspection certificate” means a [written] certification by an inspection
14 station, **IN A FORMAT ESTABLISHED BY THE DIVISION**, that:

15 (1) Certifies that, as of its date, a specified vehicle meets or exceeds
16 the standards for equipment established under this title; and

17 (2) [Is signed and dated on behalf of] **IDENTIFIES** the inspection
18 station [by] **AND** the registered individual who personally inspected the vehicle.

19 (f) “Inspection station” means a facility that is licensed by the Division
20 under this subtitle.

21 23–103.

22 (a) (1) On receipt of an application and a nonrefundable fee established by
23 the Administration from a facility for an inspection station license, the Division shall:

24 (i) Inspect the facility as to its ability to inspect and correct
25 equipment; and

26 (ii) If the facility is qualified, issue to it a license as an
27 inspection station.

28 (2) On receipt of a renewal application and the annual license fee
29 established by the Administration for an inspection station, the Division shall issue
30 the renewal license if the facility is qualified.

31 (b) The license authorizes the facility to:

1 (1) Inspect a used vehicle on request of its transferor or transferee
2 [and attach an inspection certificate to the vehicle];

3 (2) Inspect the equipment of a vehicle for which a safety equipment
4 repair order has been issued and issue a repair order certification for the vehicle; and

5 (3) Inspect an ambulance on the request of its owner that is required
6 to be inspected under § 13–515 of the Education Article.

7 23–106.

8 (a) This section does not apply to:

9 (1) Any transfer of a used vehicle to any licensed dealer or to any
10 foreign dealer;

11 (2) Any transfer between:

12 (i) Spouses;

13 (ii) A parent and child; or

14 (iii) Co-owners of the vehicle to be transferred when a
15 co-owner's name is being removed from the title;

16 (3) Any transfer of a used vehicle that is not to be both titled and
17 registered in this State;

18 (4) Any transfer of a used vehicle among any agencies of the State;

19 (5) Any transfer of a used vehicle as described in § 13–503.2 of this
20 article;

21 (6) Any transfer of a used vehicle into a written inter vivos trust in
22 which the transferor is the primary beneficiary;

23 (7) Any transfer of a used island vehicle, as defined in § 13–935 of this
24 article, registered, or to be registered, as a Class K (farm area/island) vehicle; or

25 (8) Any transfer of an off-highway recreational vehicle.

26 (b) (1) Except as provided in [paragraph (4)] **PARAGRAPHS (4) AND (5)**
27 of this subsection, if any licensed dealer that also is an inspection station transfers any
28 used vehicle, it shall:

1 (i) Prepare [and attach] an inspection certificate [to a window
2 of the vehicle]; or

3 (ii) Have an inspection certificate prepared [and attached to a
4 window of the vehicle] by another inspection station.

5 (2) Except as provided in paragraphs (4) and (5) of this subsection, if
6 any other person transfers a used vehicle, the person shall obtain an inspection
7 certificate from an inspection station. [The inspection certificate shall be issued
8 without charge and attached to a window of the vehicle.]

9 (3) If a used vehicle is transferred other than by voluntary transfer or
10 is transferred by a political subdivision of the State after that subdivision obtains the
11 vehicle by proceedings pursuant to Title 12 of the Criminal Procedure Article, the
12 transferee shall obtain the inspection certificate from an authorized inspection station.
13 [The inspection certificate shall be issued without charge and attached to a window of
14 the vehicle.]

15 (4) In the case of a transfer of any used vehicle registered, or to be
16 registered, as a Class E (truck) exceeding three-fourths ton manufacturer's rated
17 capacity, Class F (tractor), Class G (freight trailer or semitrailer), or Class G (dump
18 service semitrailer) vehicle, the transferor or the transferee of the vehicle may obtain
19 the required inspection certificate.

20 (5) In the case of a transfer of any used vehicle registered or to be
21 registered, that is sold for dismantling or rebuilding purposes, the transferor or the
22 transferee of the vehicle may obtain the required inspection certificate.

23 [(6) On applying for a certificate of title of the vehicle, the transferee
24 shall remove the inspection certificate from the vehicle and present it to the
25 Administration.]

26 23-107.

27 (a) (1) Before the Administration titles and registers any used vehicle, it
28 shall require [the applicant to present] a valid inspection certificate for the vehicle.

29 [23-108.

30 The Division shall prepare inspection certificate forms and provide them
31 without charge to inspection stations. The forms shall be serially numbered and shall
32 require the information that the Administration and the Division determine.]

33 **23-108.**

34 **FOR VEHICLE TITLING AND REGISTRATION PURPOSES, THE DIVISION:**

1 **(1) SHALL ESTABLISH THE MANNER AND FORMAT FOR THE**
2 **SUBMISSION OF AN INSPECTION CERTIFICATE FOR THE TRANSFER OF A USED**
3 **MOTOR VEHICLE; AND**

4 **(2) MAY REQUIRE ELECTRONIC SUBMISSION OF THE INSPECTION**
5 **CERTIFICATE.**

6 23-109.

7 **[(g)]** A person may not attach or cause or permit to be attached to any vehicle
8 an inspection certificate knowing it to be fictitious or issued without the equipment
9 having been inspected for compliance with this subtitle.]

10 **[(h)] (G)** A person may not issue or cause or permit to be issued a repair
11 order certification knowing it to be fictitious or issued without the equipment having
12 been inspected for compliance with this subtitle.

13 **[(i)] (H)** On suspension or revocation of its license, an inspection station
14 shall surrender to the Division, at its request, the license and all related material
15 issued by the Division.

16 **[(j)] (I)** A person may not materially alter or change any equipment of a
17 vehicle for which an inspection certificate or a repair order certification has been
18 issued under this subtitle.

19 **[(k)] (J)** A person may not willfully violate any rule or regulation adopted
20 under this subtitle relating to inspection procedures and inspection station
21 requirements.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 July 1, 2014.
