## A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt – Calvert County – End Hunger Warehouse**

3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$100,000,  
4 the proceeds to be used as a grant to the Board of Directors of the End Hunger  
5 In Calvert County, Inc. for certain development or improvement purposes;  
6 providing for disbursement of the loan proceeds, subject to a requirement that  
7 the grantee provide and expend a matching fund; establishing a deadline for the  
8 encumbrance or expenditure of the loan proceeds; and providing generally for  
9 the issuance and sale of bonds evidencing the loan.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
11 MARYLAND, That:

12 (1) The Board of Public Works may borrow money and incur indebtedness on  
13 behalf of the State of Maryland through a State loan to be known as the Calvert  
14 County – End Hunger Warehouse Loan of 2014 in a total principal amount equal to  
15 the lesser of (i) \$100,000 or (ii) the amount of the matching fund provided in  
16 accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale,  
17 and delivery of State general obligation bonds authorized by a resolution of the Board  
18 of Public Works and issued, sold, and delivered in accordance with §§ 8–117 through  
19 8–124 and 8–131.2 of the State Finance and Procurement Article.

20 (2) The bonds to evidence this loan or installments of this loan may be sold  
21 as a single issue or may be consolidated and sold as part of a single issue of bonds  
22 under § 8–122 of the State Finance and Procurement Article.

23 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer  
24 and first shall be applied to the payment of the expenses of issuing, selling, and  
25 delivering the bonds, unless funds for this purpose are otherwise provided, and then  
26 shall be credited on the books of the Comptroller and expended, on approval by the  
27 Board of Public Works, for the following public purposes, including any applicable

1 architects' and engineers' fees: as a grant to the Board of Directors of the End Hunger  
2 In Calvert County, Inc. (referred to hereafter in this Act as "the grantee") for the  
3 acquisition, planning, design, construction, repair, renovation, reconstruction, and  
4 capital equipping of the End Hunger Warehouse, located in Calvert County.

5 (4) An annual State tax is imposed on all assessable property in the State in  
6 rate and amount sufficient to pay the principal of and interest on the bonds, as and  
7 when due and until paid in full. The principal shall be discharged within 15 years  
8 after the date of issuance of the bonds.

9 (5) Prior to the payment of any funds under the provisions of this Act for the  
10 purposes set forth in Section 1(3) above, the grantee shall provide and expend a  
11 matching fund. No part of the grantee's matching fund may be provided, either  
12 directly or indirectly, from funds of the State, whether appropriated or  
13 unappropriated. The fund may consist of real property, in kind contributions, or funds  
14 expended prior to the effective date of this Act. In case of any dispute as to the amount  
15 of the matching fund or what money or assets may qualify as matching funds, the  
16 Board of Public Works shall determine the matter and the Board's decision is final.  
17 The grantee has until June 1, 2016, to present evidence satisfactory to the Board of  
18 Public Works that a matching fund will be provided. If satisfactory evidence is  
19 presented, the Board shall certify this fact and the amount of the matching fund to the  
20 State Treasurer, and the proceeds of the loan equal to the amount of the matching  
21 fund shall be expended for the purposes provided in this Act. Any amount of the loan  
22 in excess of the amount of the matching fund certified by the Board of Public Works  
23 shall be canceled and be of no further effect.

24 (6) The proceeds of the loan must be expended or encumbered by the Board  
25 of Public Works for the purposes provided in this Act no later than June 1, 2021. If any  
26 funds authorized by this Act remain unexpended or unencumbered after June 1, 2021,  
27 the amount of the unencumbered or unexpended authorization shall be canceled and  
28 be of no further effect. If bonds have been issued for the loan, the amount of  
29 unexpended or unencumbered bond proceeds shall be disposed of as provided in  
30 § 8-129 of the State Finance and Procurement Article.

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
32 June 1, 2014.
