## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Country Inn Licenses**

3 FOR the purpose of authorizing the Board of License Commissioners of Frederick  
4 County to issue a Class B–CI (country inn) on–sale beer, wine and liquor license  
5 for the use of an establishment that meets certain requirements in a certain  
6 election district; and generally relating to alcoholic beverages licenses in  
7 Frederick County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B – Alcoholic Beverages**

2 (a) The provisions of this section apply only in Frederick County.

3 (c) **(1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**  
 4 **SUBSECTION,** Class A, B, and C licenses for the sale of beer only, as authorized by  
 5 this article, shall be issued for places of business located in any of the following  
 6 election districts:

7 [(1)] **(I)** Jefferson (14th);

8 [(2)] **(II)** Johnsville (17th); and

9 [(3)] **(III)** Burkittsville (22nd).

10 **(2) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A**  
 11 **CLASS B-CI (COUNTRY INN) ON-SALE BEER, WINE AND LIQUOR LICENSE FOR**  
 12 **THE USE OF AN ESTABLISHMENT THAT MEETS THE REQUIREMENTS OF §**  
 13 **6-201(L)(7)(I) OF THIS ARTICLE IN THE BURKITTSVILLE (22ND) ELECTION**  
 14 **DISTRICT.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 16 July 1, 2014.
