## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2013 – Baltimore County –**  
3 **Dundalk Youth Services Arts Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2013  
5 to authorize the matching fund requirement of a certain grant for the Dundalk  
6 Youth Services Arts Center to include real property; and generally relating to  
7 amending the Maryland Consolidated Capital Bond Loan of 2013.

8 BY repealing and reenacting, with amendments,  
9 Chapter 424 of the Acts of the General Assembly of 2013  
10 Section 1(3) Item ZA02(AC) and ZA03(Q)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:
