## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2012 – Baltimore City –**  
3 **The Miles Washington Family Support Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2012  
5 to extend the deadline for the Board of Trustees of The Miles Washington  
6 Family Support Center, Inc. to present evidence of a certain matching fund; and  
7 generally relating to amending the Maryland Consolidated Capital Bond Loan  
8 of 2012.

9 BY repealing and reenacting, with amendments,  
10 Chapter 444 of the Acts of the General Assembly of 2012, as amended by  
11 Chapter 430 of the Acts of the General Assembly of 2013  
12 Section 1(3) Item ZA02(U)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Chapter 444 of the Acts of 2012, as amended by Chapter 430 of the Acts of**

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
18 MARYLAND, That:

21 (U) Miles Washington Family Support Center. Provide a grant of  
22 \$175,000 to the Board of Trustees of The Miles Washington  
23 Family Support Center, Inc. for the planning, construction,  
24 repair, renovation, and capital equipping of the Miles  
25 Washington Family Support Center, located in Baltimore

1 City, subject to a requirement that the grantee provide and  
 2 expend a matching fund of \$50,000, and subject to a  
 3 requirement that the grantee grant and convey a historic  
 4 easement to the Maryland Historical Trust. Notwithstanding  
 5 Section 1(5) of this Act, the matching fund may consist of real  
 6 property or funds expended prior to the effective date of this  
 7 Act. **NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE**  
 8 **GRANTEE HAS UNTIL JUNE 1, 2015, TO PRESENT**  
 9 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED**  
 10 (Baltimore City) ..... 175,000

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 12 June 1, 2014.
