Description: Renovation of the existing softball field at Southern High School. Proposed work includes: construction of new player dugouts, complete reorientation of the field to move home plate into the existing outfield, necessary grading and stabilization, drainage improvements, replacement of outfield fencing and backstop.

Purpose: This renovation will improve player and spectator safety by moving homeplate away from existing driveways. It will also improve the field playability with regards to sun orientation and drainage.
