A BILL ENTITLED

1 AN ACT concerning

2 **Montgomery County – Alcoholic Beverages – Wineries**

3 **MC 21–15**

4 FOR the purpose of authorizing the Board of License Commissioners for Montgomery
5 County to issue a Class D beer and light wine license to a holder of a Class 3
6 manufacturer’s license in Montgomery County; and generally relating to alcoholic
7 beverages in Montgomery County.

8 BY repealing and reenacting, with amendments,
9 Article 2B – Alcoholic Beverages

11 Annotated Code of Maryland

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article 2B – Alcoholic Beverages**

16 2–204.

17 **(A)** A Class 3 manufacturer’s license:

18 (1) Is a winery license; and

19 (2) Authorizes the holder to:

20 (i) Establish and operate in this State a plant for fermenting and
21 bottling wine at the location described in the license;

1 (ii) Import bulk wine from the holder of a nonresident dealer's
2 permit;

3 (iii) Sell and deliver wine to any wholesale licensee or permit holder
4 in this State, or person outside of this State authorized to acquire wine;

5 (iv) Sell wine made from products grown in Maryland at a retail price
6 at the plant to persons participating in a guided tour of the facility. The purchase shall be
7 limited to not more than one quart per person per year provided the purchaser has attained
8 the Maryland legal drinking age; and

9 (v) Serve at no charge not more than 6 ounces of wines made at the
10 licensed facility to a person who is participating in a guided tour of the facility, provided
11 the person has attained the Maryland legal drinking age.

12 **(B) IN MONTGOMERY COUNTY, THE BOARD OF LICENSE COMMISSIONERS**
13 **MAY ISSUE A CLASS D BEER AND LIGHT WINE LICENSE TO A HOLDER OF A CLASS 3**
14 **MANUFACTURER'S LICENSE IN MONTGOMERY COUNTY.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
16 1, 2015.
