A BILL ENTITLED

1 AN ACT concerning

2 **Kent County – Alcoholic Beverages – Class B Wine Shop and Lounge License**

3 FOR the purpose of establishing a Class B wine shop and lounge license in Kent County;
4 specifying that the license authorizes the holder to sell wine for consumption on and
5 off the premises and to sell or serve certain foods; providing that the license holder
6 is not subject to any requirement regarding the percentage of average daily receipts
7 derived from the sale of food; allowing an individual under the legal drinking age to
8 enter the licensed premises; setting an annual license fee; and generally relating to
9 alcoholic beverages in Kent County.

11 Article 2B – Alcoholic Beverages

12 Section 4–301 to be under the new subtitle “Subtitle 3. Class B Wine Licenses”

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article 2B – Alcoholic Beverages**

18 **SUBTITLE 3. CLASS B WINE LICENSES.**

19 **4–301.**

20 **(A) THIS SECTION APPLIES ONLY IN KENT COUNTY.**

21 **(B) THERE IS A CLASS B WINE SHOP AND LOUNGE LICENSE.**

22 **(C) THE LICENSE AUTHORIZES THE HOLDER TO:**

- 2 **(2) SELL OR SERVE:**
- 3 **(I) BREAD AND OTHER BAKED GOODS;**
- 4 **(II) CHILI;**
- 5 **(III) CHOCOLATE;**
- 6 **(IV) CRACKERS;**
- 7 **(V) CURED MEAT;**
- 8 **(VI) FRUITS (WHOLE AND CUT);**
- 9 **(VII) SALADS AND VEGETABLES (WHOLE AND CUT);**
- 10 **(VIII) HARD AND SOFT CHEESE (WHOLE AND CUT);**
- 11 **(IX) THE FOLLOWING ITEMS MADE WITH MARYLAND WINE:**
- 12 1. **ICE CREAM;**
- 13 2. **JELLY;**
- 14 3. **JAM; AND**
- 15 4. **VINEGAR;**
- 16 **(X) PIZZA;**
- 17 **(XI) PREPACKAGED SANDWICHES AND OTHER PREPACKAGED**
18 **FOODS READY TO BE EATEN;**
- 19 **(XII) SOUP; AND**
- 20 **(XIII) CONDIMENTS.**
- 21 **(D) THE LICENSE HOLDER IS NOT SUBJECT TO ANY REQUIREMENT**
22 **REGARDING THE PERCENTAGE OF AVERAGE DAILY RECEIPTS DERIVED FROM THE**
23 **SALE OF FOOD.**

1 **(E) AN INDIVIDUAL UNDER THE LEGAL DRINKING AGE MAY ENTER THE**
2 **LICENSED PREMISES.**

3 **(F) THE ANNUAL LICENSE FEE IS \$300.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
5 1, 2015.
