1 AN ACT concerning

2 **Alcoholic Beverages – Prince George's County – Seven Day Sales**

3 **PG 318–15**

4 FOR the purpose of establishing a special Sunday off–sale permit in Prince George's
5 County; authorizing the Board of License Commissioners, except under certain
6 circumstances, to issue the permit to certain license holders; providing that no more
7 than a certain number of permits may be active at any one time; prohibiting the
8 Board of License Commissioners from issuing a permit to certain holders of a license;
9 prohibiting the Board of License Commissioners from issuing a permit to certain
10 holders of a license before a certain date; requiring an applicant for a permit to
11 commit to making a certain reinvestment in the business; authorizing the Board of
12 License Commissioners to waive the reinvestment requirement; requiring the Board
13 of License Commissioners to revoke a permit under certain circumstances;
14 authorizing the permit holder to sell certain alcoholic beverages during a certain
15 time on Sunday for consumption off the licensed premises; providing that the holder
16 of a certain license that is issued a permit is no longer required to comply with any
17 restaurant or food requirements; establishing a certain application fee; establishing
18 a certain fee for the permit; authorizing the Board of License Commissioners to adopt
19 certain regulations; providing for the application of a certain provision of this Act;
20 making conforming changes; making stylistic changes; and generally relating to
21 alcoholic beverages in Prince George's County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article 2B – Alcoholic Beverages**

17 11–517.

18 (a) This section applies only in Prince George’s County.

19 (b) (1) (i) A holder of any retail “on–sale” alcoholic beverage license or any
20 agent, servant or employee of a holder of any “on–sale” alcoholic beverage license may not
21 sell or serve any alcoholic beverages for consumption on the licensed premises or permit
22 any alcoholic beverages to be consumed on the licensed premises between the hours of 2:00
23 a.m. and 6:00 a.m., except as provided in subsection (c) of this section.

24 (ii) Holders of any “on–sale” retail alcoholic beverage license, their
25 agents, servants, or employees may sell beer and light wine on Sunday for consumption on
26 the licensed premises, except between the hours of 2:00 a.m. and 8:00 a.m.

27 (iii) Subject to paragraph (2) of this subsection, a holder of any Class
28 B restaurant license, with or without [a] AN ON–SALE Sunday permit **THAT AUTHORIZES**
29 **THE HOLDER TO SELL LIQUOR BY THE GLASS**, may sell beer, wine and liquor on Sunday
30 when it falls on Christmas Eve or New Year’s Eve, except between the hours of 2:00 a.m.
31 and 8:00 a.m.

32 (2) (i) Subject to subparagraph (ii) of this paragraph, a holder of a Class
33 A retail “off–sale” alcoholic beverages license or a Class B or D alcoholic beverages license
34 with off–sale privileges, or any agent, servant or employee of the holder, may not sell any
35 alcoholic beverages for consumption off the licensed premises between the hours of 12:00
36 a.m. and 6:00 a.m.

1 (ii) A holder of a Class A beer, wine and liquor license or any agent,
 2 servant or employee of a holder of a Class A beer, wine and liquor license may not make
 3 any sale on Sunday after 12:00 a.m. [except when] **UNLESS:**

4 1. December 24 and 31 fall on a Sunday; **OR**

5 2. **THE HOLDER OF A CLASS A BEER, WINE AND LIQUOR**
 6 **LICENSE HOLDS A SPECIAL SUNDAY OFF-SALE PERMIT UNDER SUBSECTION (L) OF**
 7 **THIS SECTION.**

8 (f) (1) (I) [Notwithstanding any other provisions of this article, but in
 9 addition thereto] **EXCEPT AS PROVIDED IN SUBSECTION (L) OF THIS SECTION AND**
 10 **SUBPARAGRAPH (II) OF THIS PARAGRAPH,** the holder of a **CLASS B** beer, wine and
 11 liquor license, [Class B, his agents, servants or employees] **AND AN AGENT, A SERVANT,**
 12 **OR AN EMPLOYEE OF A HOLDER OF A CLASS B BEER, WINE AND LIQUOR LICENSE**
 13 may not sell any alcoholic beverages for consumption off the licensed premises between the
 14 hours of 12:00 a.m. and 6:00 a.m. or on Sunday after 12:00 a.m. from any separate store
 15 established on the licensed premises as an “off-sale store” or to keep an “off-sale store”
 16 open for business on Sunday after 12:00 a.m. [except that beer].

17 (II) **BEER** and light wine only may be sold from an “off-sale” store
 18 which is attached to and a part of the licensed premises on Sunday after 8:00 a.m. until
 19 12:00 a.m. the day following.

20 (2) For the [purpose] **PURPOSES** of this [provision] **SUBSECTION,** the
 21 Board of License Commissioners shall determine by reasonable standards what shall
 22 constitute an “off-sale store”.

23 (3) Nothing further herein shall be construed to permit sales at any time
 24 between 12:00 a.m. and 6:00 a.m. of any day.

25 (L) (1) **THERE IS A SPECIAL SUNDAY OFF-SALE PERMIT.**

26 (2) ~~THE~~ **SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION AND**
 27 **EXCEPT AS PROVIDED IN PARAGRAPHS (4) AND (5) OF THIS SUBSECTION, THE**
 28 **BOARD OF LICENSE COMMISSIONERS MAY ISSUE THE PERMIT TO THE HOLDER OF:**

29 (I) ~~ANY A~~ **CLASS A BEER, WINE AND LIQUOR LICENSE; OR**

30 (II) **A CLASS B BEER, WINE AND LIQUOR LICENSE WITH AN**
 31 **OFF-SALE PRIVILEGE UNDER § 6-201(R)(2)(II) OF THIS ARTICLE.**

32 (3) **NOT MORE THAN 100 SPECIAL SUNDAY OFF-SALE PERMITS MAY**
 33 **BE IN EFFECT AT ANY ONE TIME.**

1 **(4) (I) THIS PARAGRAPH APPLIES TO A HOLDER OF A LICENSE**
2 **LISTED IN PARAGRAPH (2) OF THIS SUBSECTION THAT WAS ISSUED THE LICENSE**
3 **BEFORE JULY 1, 2015.**

4 **(II) IF THE HOLDER OF A LICENSE HAS BEEN FOUND BY THE**
5 **BOARD OF LICENSE COMMISSIONERS TO HAVE VIOLATED A RESTRICTION ON**
6 **SELLING LIQUOR ON SUNDAY, THE BOARD OF LICENSE COMMISSIONERS MAY NOT**
7 **ISSUE A SPECIAL SUNDAY OFF-SALE PERMIT TO THE HOLDER BEFORE:**

8 **1. JANUARY 1, 2016, IF THE HOLDER:**

9 **A. COMMITTED ONLY ONE VIOLATION BETWEEN JULY 1,**
10 **2014, AND JUNE 30, 2015, BOTH INCLUSIVE; AND**

11 **B. DID NOT COMMIT A VIOLATION OF A RESTRICTION ON**
12 **SELLING LIQUOR ON SUNDAY BETWEEN JULY 1, 2013, AND JUNE 30, 2014, BOTH**
13 **INCLUSIVE; OR**

14 **2. JULY 1, 2016, IF THE HOLDER COMMITTED AT LEAST**
15 **TWO VIOLATIONS BETWEEN JULY 1, 2013, AND JUNE 30, 2015, BOTH INCLUSIVE.**

16 **(5) THE BOARD OF LICENSE COMMISSIONERS MAY NOT ISSUE A**
17 **SPECIAL SUNDAY OFF-SALE PERMIT TO A HOLDER OF A LICENSE LISTED IN**
18 **PARAGRAPH (2) OF THIS SUBSECTION THAT WAS FOUND BY THE BOARD OF LICENSE**
19 **COMMISSIONERS TO HAVE VIOLATED A RESTRICTION ON SELLING LIQUOR ON**
20 **SUNDAY WITHOUT A SPECIAL SUNDAY OFF-SALE PERMIT ON OR AFTER JULY 1,**
21 **2015.**

22 **(6) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
23 **PARAGRAPH, AN APPLICANT FOR A SPECIAL SUNDAY OFF-SALE PERMIT SHALL**
24 **COMMIT IN THE APPLICATION TO REINVESTING A MINIMUM OF \$50,000 IN THE**
25 **BUSINESS WITHIN 1 YEAR AFTER THE PERMIT IS ISSUED.**

26 **(II) THE BOARD OF LICENSE COMMISSIONERS MAY WAIVE THE**
27 **REINVESTMENT REQUIREMENT.**

28 **(III) THE BOARD OF LICENSE COMMISSIONERS SHALL REVOKE**
29 **A SPECIAL SUNDAY OFF-SALE PERMIT IF:**

30 **1. THE BOARD OF LICENSE COMMISSIONERS DID NOT**
31 **WAIVE THE REINVESTMENT REQUIREMENT UNDER SUBPARAGRAPH (II) OF THIS**
32 **PARAGRAPH; AND**

1 **2. THE HOLDER OF THE SPECIAL SUNDAY OFF-SALE**
2 **PERMIT FAILS TO MAKE THE REQUIRED REINVESTMENT.**

3 ~~(3)~~ **(7) THE PERMIT AUTHORIZES THE SALE OF ALCOHOLIC BEVERAGES**
4 **THAT THE HOLDER IS AUTHORIZED TO SELL:**

5 **(I) ON SUNDAY, FROM 8 A.M. TO MIDNIGHT; AND**

6 **(II) FOR CONSUMPTION OFF THE LICENSED PREMISES ONLY.**

7 **(8) IF THE HOLDER OF A CLASS B BEER, WINE AND LIQUOR LICENSE**
8 **WITH AN OFF-SALE PRIVILEGE IS ISSUED A SPECIAL SUNDAY OFF-SALE PERMIT,**
9 **THE HOLDER IS NO LONGER REQUIRED TO COMPLY WITH ANY RESTAURANT OR**
10 **FOOD REQUIREMENTS.**

11 **(9) THE APPLICATION FEE FOR A SPECIAL SUNDAY OFF-SALE**
12 **PERMIT IS \$750.**

13 ~~(4)~~ **(10) (I) THE ANNUAL PERMIT FEE FOR THE SPECIAL SUNDAY**
14 **OFF-SALE PERMIT IS \$450:**

15 **1. FOR THE HOLDER OF A CLASS A BEER, WINE AND**
16 **LIQUOR LICENSE, \$2,590; AND**

17 **2. FOR THE HOLDER OF A CLASS B BEER, WINE AND**
18 **LIQUOR LICENSE WITH AN OFF-SALE PRIVILEGE, \$1,080, ~~WHICH~~**

19 **(II) THE ANNUAL PERMIT FEE LISTED IN SUBPARAGRAPH (I) OF**
20 **THIS PARAGRAPH IS IN ADDITION TO THE ANNUAL FEE FOR THE CLASS A BEER,**
21 **WINE AND LIQUOR LICENSE OR CLASS B BEER, WINE AND LIQUOR LICENSE TO**
22 **WHICH IT IS ATTACHED.**

23 ~~(5)~~ **(11) THE BOARD OF LICENSE COMMISSIONERS MAY ADOPT**
24 **REGULATIONS TO CARRY OUT THIS SUBSECTION.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
26 1, 2015.
