A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Multiple Event Licenses and**
3 **Promoter’s License**

4 FOR the purpose of authorizing an applicant in Frederick County to purchase a certain
5 single–day alcoholic beverages license or multiday alcoholic beverages license;
6 specifying the maximum number of days for which licenses may be issued to a single
7 applicant in a calendar year; specifying the fees for certain single–day licenses and
8 multiday licenses; establishing a promoter’s license in the County; requiring a
9 for–profit organization to obtain a promoter’s license from the Board of License
10 Commissioners before the organization may conduct certain activities related to
11 events at which alcoholic beverages are sold or served and that are held in
12 conjunction with a certain organization; providing for certain license fees;
13 authorizing the Board to adopt certain regulations; and generally relating to
14 alcoholic beverages licenses in Frederick County.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
26 That the Laws of Maryland read as follows:

27 **Article 2B – Alcoholic Beverages**

2 (b) (7) (I) THIS PARAGRAPH APPLIES ONLY IN FREDERICK COUNTY.

3 (II) AN APPLICANT MAY PURCHASE:

4 1. A SINGLE-DAY SPECIAL CLASS C BEER LICENSE OR
5 BEER AND WINE LICENSE FOR EACH DAY A LICENSE IS REQUIRED; OR

6 2. A MULTIDAY SPECIAL CLASS C BEER LICENSE OR
7 BEER AND WINE LICENSE FOR ALL DAYS FOR WHICH A LICENSE IS REQUIRED.

8 (III) THE TOTAL NUMBER OF DAYS FOR WHICH LICENSES UNDER
9 THIS PARAGRAPH MAY BE ISSUED TO A SINGLE APPLICANT MAY NOT EXCEED 50
10 DAYS IN A CALENDAR YEAR.

11 (IV) [In Frederick County the] THE fee is \$10 per day FOR:

12 1. A SINGLE-DAY SPECIAL CLASS C BEER LICENSE OR
13 BEER AND WINE LICENSE; OR

14 2. A MULTIDAY SPECIAL CLASS C BEER OR BEER AND
15 WINE LICENSE.

16 (d) (8) (I) THIS PARAGRAPH APPLIES ONLY IN FREDERICK COUNTY.

17 (II) AN APPLICANT MAY PURCHASE:

18 1. A SINGLE-DAY SPECIAL CLASS C BEER, WINE AND
19 LIQUOR LICENSE FOR EACH DAY A LICENSE IS REQUIRED; OR

20 2. A MULTIDAY SPECIAL CLASS C BEER, WINE AND
21 LIQUOR LICENSE FOR ALL DAYS FOR WHICH A LICENSE IS REQUIRED.

22 (III) THE TOTAL NUMBER OF DAYS FOR WHICH LICENSES UNDER
23 THIS PARAGRAPH MAY BE ISSUED TO A SINGLE APPLICANT MAY NOT EXCEED 50

26 1. A SINGLE-DAY SPECIAL CLASS C BEER, WINE AND
27 LIQUOR LICENSE; OR

2 **LIQUOR LICENSE.**

4 **(A) THIS SECTION APPLIES ONLY IN FREDERICK COUNTY.**

5 **(B) THERE IS A PROMOTER'S LICENSE.**

6 **(C) A FOR-PROFIT ORGANIZATION SHALL OBTAIN A PROMOTER'S LICENSE**
7 **FROM THE BOARD OF LICENSE COMMISSIONERS BEFORE THE ORGANIZATION MAY**
8 **HELP PUBLICIZE, SELL TICKETS FOR, ORGANIZE, OPERATE, PRODUCE, OR STAGE AN**
9 **EVENT:**

10 **(1) AT WHICH ALCOHOLIC BEVERAGES ARE SOLD OR SERVED; AND**

11 **(2) THAT IS CONDUCTED IN CONJUNCTION WITH AN ORGANIZATION**
12 **THAT HOLDS A SPECIAL LICENSE ISSUED UNDER § 7-101 OF THIS TITLE.**

13 **(D) THE BOARD MAY ADOPT REGULATIONS ESTABLISHING REQUIREMENTS**
14 **FOR CONDUCTING AN EVENT DESCRIBED IN SUBSECTION (C) OF THIS SECTION,**
15 **INCLUDING HEALTH AND SAFETY STANDARDS TO BE MET BY A HOLDER OF A**
16 **PROMOTER'S LICENSE.**

17 **(E) THE FEE FOR A PROMOTOR'S LICENSE IS:**

18 **(1) \$250, IF THE PROMOTER EXPECTS THAT FEWER THAN 1,000**
19 **INDIVIDUALS WILL ATTEND;**

20 **(2) \$600, IF THE PROMOTER EXPECTS THAT FROM 1,001 TO 3,000**
21 **INDIVIDUALS WILL ATTEND; AND**

22 **(3) \$1,000, IF THE PROMOTER EXPECTS THAT MORE THAN 3,000**
23 **INDIVIDUALS WILL ATTEND.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2015.
