CHAPTER _____

1 AN ACT concerning

2 **Motor Vehicle Administration – Commercial Driver’s License – Program for**
3 **Veterans and Service Members**
4 **(Troops to Trucks)**

5 FOR the purpose of requiring the Motor Vehicle Administration to establish a program to
6 assist veterans and members of the military transitioning out of military service to
7 obtain a commercial driver’s license ~~and find employment~~; requiring the
8 Administration, as part of the program, to waive a certain skills test for certain
9 program participants, and coordinate *and consult* with certain ~~persons~~ *entities* to
10 ~~provide~~ explore the feasibility of providing certain education courses *a commercial*
11 *driver’s license training course* on military bases *in the State*, ~~and establish a certain~~
12 ~~process; requiring; authorizing~~ the Administration to adopt certain regulations;
13 making a conforming change; and generally relating to commercial drivers’ licenses.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Transportation**

14 16–807.

15 (b) (1) **[An] EXCEPT AS PROVIDED IN § 16–807.1 OF THIS SUBTITLE, AN**
16 individual may not be issued a commercial driver’s license until the individual has passed
17 the knowledge and skill tests for driving a commercial motor vehicle which complies with
18 the minimum federal standards established by the federal Commercial Motor Vehicle
19 Safety Act of 1986 (Title XII of Public Law 99–570), and has satisfied all other requirements
20 of that act as well as any other requirements of this title.

21 (2) The tests shall be prescribed and conducted at the direction of the
22 Administration.

23 (3) The Administration shall adopt regulations to waive the skill test
24 required under paragraph (1) of this subsection in a manner consistent with 49 C.F.R. §
25 383.77.

27 **(A) THE ADMINISTRATION SHALL ESTABLISH A PROGRAM TO ASSIST**
28 **VETERANS AND MEMBERS OF THE MILITARY WHO ARE TRANSITIONING OUT OF**
29 **MILITARY SERVICE TO OBTAIN A COMMERCIAL DRIVER’S LICENSE ~~AND FIND~~**
30 **EMPLOYMENT.**

31 **(B) AS PART OF THE PROGRAM, THE ADMINISTRATION SHALL:**

32 **(1) WAIVE THE SKILLS TEST REQUIRED UNDER § 16–807(B) OF THIS**
33 **SUBTITLE FOR PROGRAM PARTICIPANTS WHO MEET ELIGIBILITY CRITERIA**
34 **ESTABLISHED BY THE ADMINISTRATION, CONSISTENT WITH FEDERAL LAW; AND**

 2 THE STATE, COMMUNITY COLLEGES THAT OFFER COMMERCIAL ~~DRIVER EDUCATION~~

 13 October 1, 2015.
