## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **General Assembly – Joint Committee on Ending Homelessness – Membership**

3 FOR the purpose of altering the membership of the Joint Committee on Ending  
4 Homelessness; requiring that members of the Joint Committee appointed as a result  
5 of this Act reflect the geographic diversity of the State; and generally relating to the  
6 membership of the Joint Committee on Ending Homelessness.

7 BY repealing and reenacting, with amendments,

9 Section 2–10A–15

10 Annotated Code of Maryland

11 (2014 Replacement Volume and 2015 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – State Government**

15 2–10A–15.

16 (a) There is a Joint Committee on Ending Homelessness.

17 (b) (1) The Committee consists of [10] **16** members.

18 (2) Of the [10] **16** members:

1 (i) [~~five~~] **EIGHT** shall be members of the Senate of Maryland,  
2 appointed by the President of the Senate; and

3 (ii) [~~five~~] **EIGHT** shall be members of the House of Delegates,  
4 appointed by the Speaker of the House.

5 (c) (1) The members of the Committee serve at the pleasure of the presiding  
6 officer who appointed them.

7 (2) (i) If a vacancy occurs among the Senators on the Committee, a  
8 successor promptly shall be appointed by the President of the Senate.

9 (ii) If a vacancy occurs among the Delegates on the Committee, a  
10 successor promptly shall be appointed by the Speaker of the House.

11 (d) From among the membership of the Committee, the President of the Senate  
12 shall appoint a Senator to serve as the Senate Chair of the Committee, and the Speaker of  
13 the House shall appoint a Delegate to serve as the House Chair of the Committee.

14 (e) A majority of the full authorized membership of the Committee is a quorum.

15 (f) The Department of Legislative Services shall provide staff assistance to the  
16 Committee.

17 (g) The Committee shall hold:

18 (1) an organizational meeting promptly after the appointment of its  
19 members; and

20 (2) any other meetings that the Committee considers necessary to carry out  
21 its duties efficiently.

22 (h) The Committee may:

23 (1) hold a hearing on any matter relating to the functions of the Committee;  
24 and

25 (2) consider a vote on a bill or resolution referred to the Committee by the  
26 President of the Senate or the Speaker of the House.

27 (i) To ensure that public resources, programs, and policies are coordinated and  
28 effective in preventing, mitigating the effects of, and ending homelessness in Maryland, the  
29 Committee shall:

30 (1) study issues relating to homelessness, including:

- 1 (i) housing;
- 2 (ii) income;
- 3 (iii) health care;
- 4 (iv) education;
- 5 (v) government supports; and
- 6 (vi) veterans experiencing homelessness;

7 (2) consult with governmental agencies, community-based organizations,  
8 and other stakeholders to identify State policies, programs, and actions that should or could  
9 prevent, mitigate the effects of, and end homelessness in Maryland;

10 (3) review and make recommendations to align State statutes, regulations,  
11 programs, services, and budgetary priorities with the State policies and actions described  
12 in item (2) of this subsection;

13 (4) search for any intradepartmental or interdepartmental gaps,  
14 inconsistencies, and inefficiencies in the implementation or attainment of the State policies,  
15 programs, and actions described in item (2) of this subsection; and

16 (5) identify new laws, regulations, programs, services, and budgetary  
17 priorities that are needed to prevent, mitigate the effects of, and end homelessness in  
18 Maryland.

19 (j) The Governor's Interagency Council on Homelessness shall:

20 (1) cooperate fully with the Committee;

21 (2) keep the Committee fully informed as to its priorities and progress; and

22 (3) submit an annual report, subject to § 2-1246 of this title, to the  
23 Committee on or before October 1 of each year that includes:

24 (i) a description of the Council's work;

25 (ii) a report on the Council's priorities and progress; and

26 (iii) recommendations for new laws, regulations, programs, services,  
27 and budgetary priorities that are needed to prevent, mitigate the effects of, and end  
28 homelessness in Maryland.

29 (k) (1) Subject to § 2-1246 of this title, the Committee shall submit a report to  
30 the General Assembly on or before December 1 each year.

- 1                   (2)    The report shall include:
- 2                           (i)     a description of the work of the Committee; and
- 3                           (ii)    any recommendations of the Committee.

4           SECTION 2. AND BE IT FURTHER ENACTED, That the members of the Joint  
 5 Committee on Ending Homelessness appointed as a result of this Act shall reflect the  
 6 geographic diversity of the State.

7           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 8 October 1, 2016.
