## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Cecil County – Sheriff – Salary**

3 FOR the purpose of altering the salary of the Sheriff of Cecil County beginning with a  
4 certain term of office; providing for the application of this Act; and generally relating  
5 to the salary of the Sheriff of Cecil County.

6 BY repealing and reenacting, with amendments,  
7 Article – Courts and Judicial Proceedings  
8 Section 2–309(i)(1)(i)  
9 Annotated Code of Maryland  
10 (2013 Replacement Volume and 2015 Supplement)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That the Laws of Maryland read as follows:

13 **Article – Courts and Judicial Proceedings**

14 2–309.

15 (i) (1) (i) The Sheriff of Cecil County shall receive an annual salary of:

16 1. \$71,500 for fiscal year 2015;

17 2. \$75,075 for fiscal year 2016;

7 ~~THE COUNTY EXECUTIVE OF CECIL COUNTY AT THE BEGINNING OF THE SHERIFF'S~~  
8 ~~TERM OF OFFICE~~ NOT LESS THAN \$100,000, AS DETERMINED BY THE COUNTY  
9 COUNCIL OF CECIL COUNTY.

10 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35  
11 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary  
12 or compensation of the Sheriff of Cecil County while serving in a term of office beginning  
13 before the effective date of this Act, but the provisions of this Act concerning the salary or  
14 compensation of the Sheriff of Cecil County shall take effect at the beginning of the next  
15 following term of office. This limitation does not apply to an individual appointed or elected  
16 after the effective date of this Act to fill out an unexpired term.

17 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
18 October 1, 2016.
