## A BILL ENTITLED

1 AN ACT concerning

2 **Allegany County – Alcoholic Beverages – Sunday Sales**

3 FOR the purpose of altering the hours for sale of certain alcoholic beverages on Sundays by  
4 a holder of a Class D beer license, a Class D beer and light wine license, a Class B  
5 beer, wine, and liquor license, and a Class D beer, wine, and liquor license in  
6 Allegany County under certain circumstances; and generally relating to the hours  
7 for sale of alcoholic beverages on Sundays in Allegany County.

8 BY repealing and reenacting, without amendments,

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

4 (b) “Board” means the Board of License Commissioners for Allegany County.

6 This title applies only in Allegany County.

7 9–2002.

8 (d) (1) Except as provided in § 9–2005 of this subtitle for December 31 and  
9 January 1, a holder of a Class D beer license may sell beer:

10 (i) on Monday through Saturday, for on–premises and off–premises  
11 consumption, from 7 a.m. to 2 a.m. the following day;

12 (ii) on Sunday, for on–premises consumption, from [1 p.m.] **11 A.M.**  
13 to 2 a.m. the following day if the holder:

14 1. pays an additional fee of \$250; and

15 2. is issued the license for use in a restaurant in a permanent  
16 building with ample space and accommodations where meals are usually prepared, sold, or  
17 served to the public when the restaurant is regularly open for business; or

18 (iii) in accordance with a 2–day Sunday sales permit issued under  
19 paragraph (2) of this subsection.

20 (2) (i) The Board may issue a 2–day Sunday sales permit to a holder of  
21 a Class D beer license.

22 (ii) An applicant for a 2–day Sunday sales permit need not have  
23 kitchen facilities on the licensed premises.

24 (iii) A 2–day Sunday sales permit authorizes the holder to sell beer  
25 for on–premises consumption on not more than two Sundays in a year from [1 p.m.] **11**  
26 **A.M.** Sunday to 2 a.m. the following day.

27 (iv) The permit fee is \$50 for each time the permit is used.

28 9–2003.

29 (d) (1) Except as provided in § 9–2005 of this subtitle for December 31 and  
30 January 1, a holder of a Class D beer and light wine license may sell beer and light wine:

1 (i) on Monday through Saturday, for on-premises and off-premises  
2 consumption, from 7 a.m. to 2 a.m. the following day;

3 (ii) on Sunday, for on-premises consumption, from [1 p.m.] **11 A.M.**  
4 to 2 a.m. the following day if the holder:

5 1. pays an additional fee of \$250; and

6 2. is issued the license for use in a restaurant in a permanent  
7 building with ample space and accommodations where meals are usually prepared, sold, or  
8 served to the public when the restaurant is regularly open for business; or

9 (iii) in accordance with a 2-day Sunday sales permit issued under  
10 paragraph (2) of this subsection.

11 (2) (i) The Board may issue a 2-day Sunday sales permit to a holder of  
12 a Class D beer and light wine license.

13 (ii) An applicant for a 2-day Sunday sales permit need not have  
14 kitchen facilities on the licensed premises.

15 (iii) A 2-day Sunday sales permit authorizes the holder to sell beer  
16 and light wine for on-premises consumption on not more than two Sundays in a year from  
17 [1 p.m.] **11 A.M.** Sunday to 2 a.m. the following day.

18 (iv) The permit fee is \$50 for each time the permit is used.

19 9-2004.

20 (b) (1) Except as provided in § 9-2005 of this subtitle for December 31 and  
21 January 1, a holder of a Class B beer, wine, and liquor license may sell beer, wine, and  
22 liquor:

23 (i) on Monday through Saturday, for on-premises and off-premises  
24 consumption, from 7 a.m. to 2 a.m. the following day;

25 (ii) on Sunday, for on-premises consumption, from [1 p.m.] **11 A.M.**  
26 to 2 a.m. the following day if the holder:

27 1. pays an additional fee of \$250;

28 2. is issued the license for use in a restaurant in a permanent  
29 building with ample space and accommodations where meals are usually prepared, sold, or  
30 served to the public when the restaurant is regularly open for business; or

1                                   3.       is issued a 2–day Sunday sales permit in accordance with  
2 paragraph (2) of this subsection.

3                                   (2)   (i)       The Board may issue a 2–day Sunday sales permit to a holder of  
4 a Class B beer, wine, and liquor license, including a Class B beer, wine, and liquor license  
5 issued for use in a restaurant or banquet room in a hotel or motel.

6                                   (ii)   An applicant for a 2–day Sunday sales permit need not have  
7 kitchen facilities on the licensed premises.

8                                   (iii)  A 2–day Sunday sales permit authorizes the holder to sell beer,  
9 wine, and liquor for on–premises consumption on not more than two Sundays in a year  
10 from [1 p.m.] 11 A.M. Sunday to 2 a.m. the following day.

11                                  (iv)   The permit fee is \$50 for each time the permit is used.

12                                  (d)   (1)    Except as provided in § 9–2005 of this subtitle for December 31 and  
13 January 1, a holder of a Class D beer, wine, and liquor license may sell beer, wine, and  
14 liquor:

2           The Board shall determine the hours of sale for December 31 and January 1,  
3 regardless of the days of the week on which those dates fall.

4           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
5 1, 2016.
