2 **Frederick County ~~and St. Mary's County~~ – Alcoholic Beverages – Art Gallery**
3 **Beer and Wine License**

4 FOR the purpose of authorizing the Board of License Commissioners for Frederick County
5 ~~and the Board of License Commissioners for St. Mary's County~~ to issue an art gallery
6 beer and wine license to nonprofit and for-profit retail businesses that display and
7 sell original artwork or certain copies of original artwork by an individual or a group
8 of artists; prohibiting a certain type of business from being issued the license;
9 specifying that a holder of the license may sell or serve beer and wine at retail for
10 on-premises consumption when snacks are served during certain hours; specifying
11 a license fee; prohibiting the license from being transferred from the location for
12 which the license was originally issued to another location; and generally relating to
13 an art gallery license in Frederick County ~~and St. Mary's County~~.
