A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Theater License**

3 FOR the purpose of altering the scope of a certain alcoholic beverages license in Frederick
4 County so that it may be issued to all theaters that meet a certain seating
5 requirement; making a certain technical correction; and generally relating to
6 alcoholic beverages licenses in Frederick County.

7 BY renumbering

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That Section(s) 20–1008, 20–1009, 20–1010, 20–1011, 20–1012, and 20–1013, respectively,
22 of Article – Alcoholic Beverages of the Annotated Code of Maryland be renumbered to be
23 Section(s) 20–1013, 20–1008, 20–1009, 20–1010, 20–1011, and 20–1012, respectively.

24 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
25 as follows:

26 **Article – Alcoholic Beverages**

2 (a) There is a Class C [(Maryland Ensemble Theatre)] **(THEATER)** beer and wine
3 license.

4 (b) (1) The president and two other officers of the [Maryland Ensemble
5 Theatre] **THEATER** shall sign the application for the license.

6 (2) Two of the signers shall be residents of the County.

7 (c) The Board may issue a license for use by [the Maryland Ensemble Theatre] **A**
8 **THEATER WITH SEATING FOR 200 OR FEWER INDIVIDUALS PER PERFORMANCE.**

9 (d) [The license authorizes the license holder to sell beer and wine for
10 on-premises consumption.

11 (e) The license [holder may] **AUTHORIZES THE LICENSE HOLDER TO** sell beer
12 and wine for on-premises consumption from 1 hour before to 1 hour after:

13 (1) a regular performance; or

14 (2) a fund-raiser performance that benefits the [Maryland Ensemble
15 Theatre] **THEATER.**

16 **[(f)] (E)** The annual license fee is \$100.

17 **SECTION 3. AND BE IT FURTHER ENACTED,** That this Act shall take effect July
18 1, 2016.
