1 AN ACT concerning

2 **Cecil County Board of Education – Members – Salary**

3 FOR the purpose of altering the amount of compensation of the president and other voting
4 members of the Cecil County Board of Education; making conforming changes;
5 providing that this Act does not apply to the compensation of the president or other
6 voting members of the board during a certain term of office; and generally relating
7 to the compensation of the members of the Cecil County Board of Education.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 3–4A–04.

17 (a) The president of the county board ~~is~~ is entitled to receive NOT LESS THAN
18 \$4,000 annually as compensation~~]~~ and the other voting members are entitled to receive
19 NOT LESS THAN ~~[\$3,500]~~ ~~NOT LESS THAN \$5,000~~ each annually as compensation, AS
20 **DETERMINED BY THE COUNTY COUNCIL OF CECIL COUNTY.**

1 (b) The president of the county board and other members are entitled to
2 reimbursement not to exceed \$1,000 a year for travel and other expenses.

3 [(c) The Cecil County Commissioners may increase the annual salary of the county
4 board.]

5 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35
6 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary
7 or compensation of the president or other voting members of the Cecil County Board of
8 Education while serving in a term of office beginning before the effective date of this Act,
9 but the provisions of this Act concerning the salary or compensation of the president and
10 other voting members of the Cecil County Board of Education shall take effect at the
11 beginning of the next following term of office. This limitation does not apply to an individual
12 appointed or elected after the effective date of this Act to fill out an unexpired term.

13 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2017.
