20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

~~(II) A STATEMENT THAT WRITTEN COMMENTS MAY BE 9 SUBMITTED TO THE DEPARTMENT IN ACCORDANCE WITH SUBSECTION (D) OF THIS 10 SECTION.~~

~~[(e)] (D) Within 30 days after receiving A notice REQUIRED under subsection 12 (b)(1) OR (C)(1) of this section, the governing body or the member of the General Assembly 13 may submit written comments to the Department.~~

~~[(d)] (E) A lease for a site may not be executed until 31 days after the day that 15 notice is received under subsection [(b)(1)] (C)(1) of this section.~~

(a) A request for proposals for a lease of real property shall include:

(1) a work statement that shall be used as a basis for the evaluation of 19 proposals;

(2) a statement of the factors[, including price,] that will be used in 21 evaluating proposals, INCLUDING:

(I) PRICE; AND

(II) FOR A LEASE OF REAL PROPERTY TO BE USED BY A STATE 24 ENTITY THAT PROVIDES GOVERNMENT SERVICES, THAT THE LOCATION OF THE 25 REAL PROPERTY SHALL ADEQUATELY SERVE THE POPULATION THAT RECEIVES THE 26 SERVICES LOCAL DEPARTMENT OF SOCIAL SERVICES, THE GEOGRAPHIC 27 BOUNDARIES OF THE AREA WHERE THE FACILITY WILL BE LOCATED, AS 28 DETERMINED BY THE SECRETARY OF HUMAN RESOURCES, OR THE SECRETARY'S 29 DESIGNEE, AFTER CONSULTING WITH THE DIRECTOR OF THE LOCAL DEPARTMENT 30 OF SOCIAL SERVICES; and

(3) a statement of the relative importance of each factor.
