CHAPTER _____

1 AN ACT concerning

2 **Family Law – Marriage – Age Requirements**

3 FOR the purpose of repealing certain provisions authorizing certain individuals under the
4 age of majority to marry under certain circumstances; making certain conforming
5 changes; and generally relating to marriage.

6 BY repealing and reenacting, with amendments,
7 Article – Family Law
8 Section 2–301, 2–402(e), and 2–405
9 Annotated Code of Maryland
10 (2012 Replacement Volume and 2016 Supplement)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Family Law**

14 2–301.

15 [(a) An individual 16 or 17 years old may not marry unless:

1 (1) the individual has the consent of a parent or guardian and the parent
2 or guardian swears that the individual is at least 16 years old; or

3 (2) if the individual does not have the consent of a parent or guardian,
4 either party to be married gives the clerk a certificate from a licensed physician, licensed
5 physician assistant, or certified nurse practitioner stating that the physician, physician
6 assistant, or nurse practitioner has examined the woman to be married and has found that
7 she is pregnant or has given birth to a child.

8 (b) An individual 15 years old may not marry unless:

9 (1) the individual has the consent of a parent or guardian; and

10 (2) either party to be married gives the clerk a certificate from a licensed
11 physician, licensed physician assistant, or certified nurse practitioner stating that the
12 physician, physician assistant, or nurse practitioner has examined the woman to be
13 married and has found that she is pregnant or has given birth to a child.

14 (c) An individual under the age of ~~[15]~~ 18 may not marry.

15 2-402.

16 (e) Until a license becomes effective, a clerk may not disclose the fact that an
17 application for a license has been made ~~[except to the parent or guardian of a party to be~~
18 ~~married]~~.

19 2-405.

20 (a) The clerk for the county in which a marriage ceremony is to be performed may
21 issue and deliver a license at the time the application is made.

22 (b) A license may be issued only at the office of the clerk during regular office
23 hours.

24 (c) ~~[(1) If either party to be married is known to be of an age where the parental~~
25 ~~or guardian's consent and oath, or the licensed physician's certificate, required by § 2-301~~
26 ~~of this title, is required, the clerk shall obtain the consent and oath or the certificate before~~
27 ~~issuing the license.~~

28 (2) (i) The clerk's record required under this title shall include:

29 1. the consent and oath required by § 2-301 of this title, if
30 written; or

31 2. the fact that consent was given and an oath was made, if
32 given and made in person.

1 (ii) The licensed physician's certificate required by § 2-301 of this
2 title may not be made a part of the clerk's record.

3 (3) After an individual has been issued a license in accordance with the
4 provisions of this subtitle, the clerk who issued the license shall seal the licensed
5 physician's certificate. Except on order of the court, the licensed physician's certificate shall
6 remain sealed.

7 **(d)] (1)** Except as provided in paragraph (2) of this subsection, a license is not
8 effective until 6 a.m. on the second calendar day after the license is issued.

9 (2) For good cause shown, a judge of the circuit court for the county in
10 which the application is made may sign an authorization for a license to become effective
11 at a time before the waiting period expires, as stated in the authorization, if 1 of the parties
12 to be married is:

13 (i) a resident of this State; or

14 (ii) a member of the United States armed forces.

15 **[(e)] (D)** If, during the questioning of an applicant for a license, the clerk finds
16 that there is a legal reason why the applicants should not be married, the clerk shall
17 withhold the license unless ordered by the court to issue the license.

18 **[(f)] (E)** A license may be delivered personally or by mail to:

19 (1) either of the parties to be married; or

20 (2) any person authorized in writing by either of the parties to accept
21 delivery.

22 **[(g)] (F)** (1) The Department of Health and Mental Hygiene shall provide to
23 each clerk:

24 (i) birth control information; and

25 (ii) a list of the family planning clinics located in the county where
26 the license is issued.

27 (2) When the clerk issues a license, the clerk shall make the information
28 and list available to each applicant for a license.

29 **[(h)] (G)** (1) A clerk may not predate an application for a license.

30 (2) A clerk who violates any provision of this subsection is guilty of a
31 misdemeanor and on conviction is subject:

1 (i) for a first offense, to a fine not exceeding \$100; and

2 (ii) for each subsequent offense, to a fine not exceeding \$500 or
3 imprisonment not exceeding 90 days or both.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2017.
