A BILL ENTITLED

1 AN ACT concerning

2 **Pollinator Habitat Plans – Plan Contents – Requirement and Prohibition**

3 FOR the purpose of requiring that a certain pollinator habitat plan established by the
4 Department of Natural Resources, the Maryland Environmental Service, and the
5 State Highway Administration be as protective of pollinators as the Department of
6 Agriculture’s managed pollinator protection plan; prohibiting the use of certain
7 pesticides, seeds, or plants in the pollinator habitat plan; defining a certain term;
8 making conforming changes; and generally relating to pollinator habitat plans.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Agriculture**

17 2–1801.

18 (a) **IN THIS SECTION, “NEONICOTINOID PESTICIDE” HAS THE MEANING**
19 **STATED IN § 5–2A–01 OF THIS ARTICLE.**

20 (B) (1) On or before July 1, 2017, subject to paragraph (2) of this subsection,
21 the Department of Natural Resources, the Maryland Environmental Service, and the State
22 Highway Administration, in consultation with the Department, each shall establish a
23 pollinator habitat plan.

1 (2) A pollinator habitat plan required under this subsection:

2 (i) Shall include best management practices for the maintenance,
3 creation, enhancement, and restoration of pollinator habitats;

4 (ii) Shall [adhere to] **BE AS PROTECTIVE OF POLLINATORS AS** the
5 Department's managed pollinator protection plan;

6 (iii) May not require an action on land that is inconsistent with any
7 federal, State, or local law, regulation, rule, or guidance that applies to the land; [and]

8 (iv) May not require the creation of pollinator habitat on productive
9 farmland; **AND**

10 (v) **MAY NOT ALLOW THE USE OF THE FOLLOWING PESTICIDES,**
11 **SEEDS, OR PLANTS IN A POLLINATOR HABITAT PLAN:**

12 1. **NEONICOTINOID PESTICIDES;**

13 2. **PESTICIDES LABELED AS TOXIC TO BEES OR OTHER**
14 **POLLINATORS; OR**

15 3. **SEEDS OR PLANTS TREATED WITH A NEONICOTINOID**
16 **PESTICIDE.**

17 **[(b)] (C)** The Department of Natural Resources, the Maryland Environmental
18 Service, and the State Highway Administration each shall:

19 (1) On or before September 1, 2017, make available to the public on its Web
20 site the pollinator habitat plan established in accordance with subsection **[(a)] (B)** of this
21 section; and

22 (2) On or before July 1, 2018, implement the pollinator habitat plan
23 established in accordance with subsection **[(a)] (B)** of this section.

24 **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall take effect July
25 1, 2017.
