A BILL ENTITLED

1 AN ACT concerning

2 **Income Tax – Elimination of the Marriage Penalty**

3 FOR the purpose of altering the State income tax rate brackets for certain income of certain
4 married couples and individuals; altering the amount allowed as a deduction for
5 certain exemptions for certain married couples and individuals under the Maryland
6 income tax under certain circumstances; providing for the application of this Act;
7 and generally relating to altering the State income tax rates and amount allowed as
8 a deduction for certain exemptions.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Tax – General**

17 10–105.

18 (a) (1) For an individual other than an individual described in paragraph (2)
19 of this subsection, the State income tax rate is:

20 (i) 2% of Maryland taxable income of \$1 through \$1,000;

21 (ii) 3% of Maryland taxable income of \$1,001 through \$2,000;

22 (iii) 4% of Maryland taxable income of \$2,001 through \$3,000;

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



- 1 (iv) 4.75% of Maryland taxable income of \$3,001 through \$100,000;
- 2 (v) 5% of Maryland taxable income of \$100,001 through \$125,000;
- 3 (vi) 5.25% of Maryland taxable income of \$125,001 through \$150,000;
- 4 (vii) 5.5% of Maryland taxable income of \$150,001 through \$250,000;
- 5 and
- 6 (viii) 5.75% of Maryland taxable income in excess of \$250,000.

7 (2) For spouses filing a joint return or for a surviving spouse or head of
8 household as defined in § 2 of the Internal Revenue Code, the State income tax rate is:

- 9 (i) 2% of Maryland taxable income of \$1 through \$1,000;
- 10 (ii) 3% of Maryland taxable income of \$1,001 through \$2,000;
- 11 (iii) 4% of Maryland taxable income of \$2,001 through \$3,000;
- 12 (iv) 4.75% of Maryland taxable income of \$3,001 through **[\$150,000]**
13 **\$200,000**;
- 14 (v) 5% of Maryland taxable income of **[\$150,001] \$200,001** through
15 **[\$175,000] \$250,000**;
- 16 (vi) 5.25% of Maryland taxable income of **[\$175,001] \$250,001**
17 through **[\$225,000] \$300,000**;
- 18 (vii) 5.5% of Maryland taxable income of **[\$225,001] \$300,001**
19 through **[\$300,000] \$500,000**; and
- 20 (viii) 5.75% of Maryland taxable income in excess of **[\$300,000]**
21 **\$500,000**.

23 (a) Except as provided in subsection (b) of this section, whether or not a federal
24 return is filed, to determine Maryland taxable income, an individual other than a fiduciary
25 may deduct as an exemption:

26 (1) \$3,200 for each exemption that the individual may deduct in the taxable
27 year to determine federal taxable income under § 151 of the Internal Revenue Code;

1 (2) an additional \$3,200 for each dependent, as defined in § 152 of the
2 Internal Revenue Code, who is at least 65 years old on the last day of the taxable year;

3 (3) an additional \$1,000 if the individual, on the last day of the taxable
4 year, is at least 65 years old; and

5 (4) an additional \$1,000 if the individual, on the last day of the taxable
6 year, is a blind individual, as described in § 10–208(c) of this subtitle.

7 (b) (1) If an individual other than one described in paragraph (2) of this
8 subsection has federal adjusted gross income for the taxable year greater than \$100,000,
9 the amount allowed for each exemption under subsection (a)(1) or (2) of this section is
10 limited to:

11 (i) \$1,600 if federal adjusted gross income for the taxable year does
12 not exceed \$125,000;

13 (ii) \$800 if federal adjusted gross income for the taxable year is
14 greater than \$125,000 but not greater than \$150,000; and

15 (iii) \$0 if federal adjusted gross income for the taxable year is greater
16 than \$150,000.

17 (2) If a married couple filing a joint return or an individual described in §
18 2 of the Internal Revenue Code as a head of household or as a surviving spouse has federal
19 adjusted gross income for the taxable year greater than ~~[\$150,000]~~ **\$200,000**, the amount
20 allowed for each exemption under subsection (a)(1) or (2) of this section is limited to:

21 (i) \$1,600 if federal adjusted gross income for the taxable year does
22 not exceed ~~[\$175,000]~~ **\$250,000**;

23 (ii) \$800 if federal adjusted gross income for the taxable year is
24 greater than ~~[\$175,000]~~ **\$250,000** but not greater than ~~[\$200,000]~~ **\$300,000**; and

25 (iii) \$0 if federal adjusted gross income for the taxable year is greater
26 than ~~[\$200,000]~~ **\$300,000**.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
28 1, 2017, and shall be applicable to all taxable years beginning after December 31, 2016.
