4 FOR the purpose of requiring the Department of Human Resources to make available to
5 certain service providers, local administering agencies for certain service providers
6 ~~and to certain service providers a certain supply of feminine hygiene products for a~~
7 ~~certain purpose; providing that certain feminine hygiene products be made available~~
8 ~~to certain entities and to female residents in shelters for free, and county boards of~~
9 education certain supplies of feminine hygiene products for female residents in
10 shelters and certain homeless female students; requiring, alternatively, if a certain
11 contingency is met, the Department of Housing and Community Development to make
12 available to certain service providers, local administering agencies for certain service
13 providers, and county boards of education certain supplies of feminine hygiene
14 products for female residents in shelters and certain homeless female students;

30 **(3) “LOCAL ADMINISTERING AGENCY” MEANS THE AGENCY**

3 (2) “FEMININE HYGIENE PRODUCTS” MEANS TAMPONS AND SANITARY
4 NAPKINS FOR USE IN CONNECTION WITH THE MENSTRUAL CYCLE.

5 (3) “LOCAL ADMINISTERING AGENCY” MEANS THE AGENCY
6 DESIGNATED BY THE DEPARTMENT OR A LOCAL GOVERNMENT TO MANAGE THE
7 PROGRAMS FOR TRANSITIONAL HOUSING SERVICES, INCLUDING THE HOMELESS
8 WOMEN – CRISIS SHELTER HOME PROGRAM, AND TO PROVIDE A SERVICE DIRECTLY
9 OR BY CONTRACT WITH A SERVICE PROVIDER.

10 (4) “SERVICE PROVIDER” MEANS A PUBLIC OR PRIVATE NONPROFIT
11 THAT CONTRACTS WITH THE DEPARTMENT OR A LOCAL ADMINISTERING AGENCY TO
12 PROVIDE SHELTER SERVICES FOR HOMELESS INDIVIDUALS.

13 (B) (1) THE DEPARTMENT SHALL MAKE AVAILABLE TO:

15 FOR SERVICE PROVIDERS A SUPPLY OF FEMININE HYGIENE PRODUCTS SUFFICIENT
16 TO MEET THE NEEDS OF FEMALE RESIDENTS IN SHELTERS; AND

17 (II) COUNTY BOARDS OF EDUCATION A SUPPLY OF FEMININE
18 HYGIENE PRODUCTS SUFFICIENT TO MEET THE NEEDS DURING THE NORMAL

20 CHILDREN OR YOUTH UNDER THE FEDERAL MCKINNEY-VENTO HOMELESS

30 HOMELESS CHILDREN OR YOUTH UNDER THE FEDERAL MCKINNEY-VENTO

32 PROVIDED UNDER SUBSECTION (B) OF THIS SECTION.

1 SECTION 3. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take
2 effect on the taking effect of Chapter (H.B. 134) of the Acts of the General Assembly of
3 2017. If Chapter (H.B. 134) does not take effect, Section 2 of this Act shall be null and
4 void without the necessity of further action by the General Assembly. If Section 2 of this Act
5 takes effect, Section 1 shall be null and void without the necessity of further action by the
6 General Assembly.

7 SECTION 4. AND BE IT FURTHER ENACTED, That, subject to the provisions of
8 Section 3 of this Act, this Act shall take effect July 1, 2017.
