4 FOR the purpose of providing that, under certain circumstances, work that is performed by
5 ~~volunteers~~ certain workers for youth sports organizations is not covered employment
6 under the unemployment insurance law; defining certain terms; and generally
7 relating to exemptions from covered employment under unemployment insurance
8 law.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Labor and Employment**

17 8–206.

18 **(I) (1) (I) IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE**
19 **MEANINGS INDICATED.**

1 (II) "COMPENSATION" DOES NOT INCLUDE THE ACTUAL AND
2 NECESSARY EXPENSES THAT ARE:

3 1. INCURRED BY A ~~VOLUNTEER~~ QUALIFYING YOUTH
4 SPORTS WORKER IN CONNECTION WITH THE SERVICES PROVIDED OR DUTIES
5 PERFORMED FOR THE YOUTH SPORTS ORGANIZATION; AND

6 2. REIMBURSED TO THE ~~VOLUNTEER~~ QUALIFYING
7 YOUTH SPORTS WORKER ~~OR OTHERWISE PAID BY THE YOUTH SPORTS~~
8 ~~ORGANIZATION.~~

9 (III) "~~VOLUNTEER~~ QUALIFYING YOUTH SPORTS WORKER"
10 MEANS AN INDIVIDUAL WHO PROVIDES SERVICES OR PERFORMS DUTIES AS AN
11 ATHLETIC COACH, MANAGER, PROGRAM LEADER, OR TEAM ASSISTANT FOR
12 COMPENSATION NOT EXCEEDING ~~\$5,000~~ \$1,250 PER QUARTER OF A CALENDAR
13 YEAR FOR EITHER THE CURRENT CALENDAR YEAR OR THE PRECEDING CALENDAR
14 YEAR.

15 (IV) 1. "YOUTH SPORTS ORGANIZATION" MEANS AN
16 ATHLETIC OR RECREATIONAL PROGRAM:

17 A. ORGANIZED FOR COMPETITION AGAINST ANOTHER
18 TEAM, CLUB, OR ENTITY OR FOR ATHLETIC INSTRUCTION EXCLUSIVELY FOR
19 PARTICIPANTS WHO ARE UNDER THE AGE OF 19 YEARS;

20 B. ~~ORGANIZED FOR PLEASURE, RECREATION, OR OTHER~~
21 ~~NONPROFIT PURPOSES~~ THAT IS QUALIFIED UNDER § 501(C)(4) OR § 501(C)(7) OF
22 THE INTERNAL REVENUE CODE IN THE CURRENT CALENDAR QUARTER;

23 C. THAT DOES NOT HAVE ANY PART OF THE NET
24 EARNINGS BENEFITING ANY PRIVATE SHAREHOLDER; AND

25 D. THAT HAS AN ADULT EMPLOYEE OR A ~~VOLUNTEER~~
26 QUALIFYING YOUTH SPORTS WORKER WHO HAS SUPERVISORY OR DISCIPLINARY
27 AUTHORITY OVER YOUTH PARTICIPANTS.

28 2. "YOUTH SPORTS ORGANIZATION" DOES NOT
29 INCLUDE:

30 A. A PUBLIC OR PRIVATE EDUCATIONAL INSTITUTION'S
31 ATHLETIC PROGRAM; OR

32 B. A SCHOOL-ASSOCIATED ATHLETIC ACTIVITY.

1 **(2) WORK THAT IS PERFORMED BY A ~~VOLUNTEER~~ QUALIFYING YOUTH**
2 **SPORTS WORKER FOR A YOUTH SPORTS ORGANIZATION IS NOT COVERED**
3 **EMPLOYMENT.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2017.
