1 AN ACT concerning

2 **Mold Remediation Services Providers – Licensure and Program Evaluation**

3 FOR the purpose of extending to a certain date the date by which companies or firms
4 providing mold remediation services must be licensed; repealing the requirement
5 that a certain evaluation of mold remediation licensing, regulation, and services be
6 performed on or before a certain date in accordance with the Maryland Program
7 Evaluation Act (sunset law); and generally relating to mold remediation services
8 providers.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Business Regulation**

15 8–707.

16 (a) Except as otherwise provided in this subtitle, a company or firm shall be
17 licensed by the Commission before the company or firm provides mold remediation services
18 in the State.

19 8–718.

20 Subject to the evaluation and reestablishment provisions of the Maryland Program
21 Evaluation Act, this subtitle and all regulations adopted under this subtitle shall terminate
22 and be of no effect after July 1, 2019.

23 **Article – State Government**

24 8–403.

25 (a) On or before December 15 of the evaluation year specified, the Department
26 shall:

27 (1) conduct a preliminary evaluation of each governmental activity or unit
28 to be evaluated under this section; and

29 (2) prepare a report on each preliminary evaluation conducted.

30 (b) Each of the following governmental activities or units and the statutes and
31 regulations that relate to the governmental activities or units are subject to preliminary
32 evaluation in the evaluation year specified:

2 Business Regulation Article: 2016);]

3 **Chapter 537 of the Acts of 2008, as amended by Chapter 333 of the Acts of 2011**

4 SECTION 3. AND BE IT FURTHER ENACTED, That on or before [July 1, 2013]
5 **JULY 1, 2019**, a company or firm providing mold remediation services shall be licensed by
6 the Maryland Home Improvement Commission, subject to the qualification and application
7 requirements of this Act.

8 SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 8–403(b)(38)
9 through (58), respectively, of Article – State Government of the Annotated Code of
10 Maryland be renumbered to be Section(s) 8–403(b)(37) through (57), respectively.

11 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2017.
