## A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Alcoholic Beverages – Class B–D–7 Licenses – Hours of Sale**

3 FOR the purpose of specifying certain hours of sale for a holder of a Class B–D–7 beer,  
4 wine, and liquor license in a certain area of Baltimore City; and generally relating  
5 to alcoholic beverages licenses in Baltimore City.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 12–102.

20 This title applies only in Baltimore City.

21 12–905.

22 (a) There is a Class B–D–7 beer, wine, and liquor license.

1 (b) (1) The Board may issue a Class B–D–7 license if the Board determines  
2 that the license is reasonably necessary for the convenience of the public.

3 (2) In making the determination, the Board shall consider the number of  
4 beer, wine, and liquor outlets in a given area and the number of days the outlets are open,  
5 rather than the nature of the outlets.

6 (c) The license authorizes the license holder to sell beer, wine, and liquor at retail  
7 at the place described in the license, for on– and off–premises consumption.

8 (d) (1) [The] **EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**  
9 **SUBSECTION, THE** license holder may sell beer, wine, and liquor during the hours and  
10 days set out under § 12–2004(c) of this title.

11 (2) **THE HOURS OF SALE FOR A LICENSE HOLDER IN AN AREA**  
12 **BOUNDED BY LIBERTY HEIGHTS AVENUE, NORTHERN PARKWAY, DRUID PARK**  
13 **DRIVE, AND WABASH AVENUE ARE FROM 9 A.M. TO 9 P.M.**

14 (e) The Board shall adopt regulations to determine the manner of operation of a  
15 licensed premises.

16 (f) The annual license fee is \$1,320.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
18 1, 2017.
