10. Description and Purpose of Organization (Limit length to visible area)				
The grantee, Anne Arundel County Maryland is a local jurisdiction in the State of Maryland, and the owner of the subject property. Hot Sox Park is a community park managed by the Anne Arundel County Department of Recreation and Parks. The Department of Recreation and Parks is responsible for the acquisition, design, construction and management of the County park system and the delivery of recreation programs to County residents.				

11. Description and Purpose of Project (Limit length to visible area)

This project proposes to design and construct improvements to the historic Hot Sox Park baseball field to include turf renovations, restoration of the backstop, fencing, bleachers, dugouts, a new picnic shelter, picnic grills, portable toilet enclosure, entrance road, parking, landscaping and signage. Hot Sox Field is the home of the former Galesville Hot Sox, a professional baseball team formed in 1915 as part of the "Negro League Ballplayers Association". Improvements will be performed with oversight by the Anne Arundel County Cultural Resources Division to preserve the historic character of the field.
