A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Forfeiture Proceedings – Notice**

3 FOR the purpose of authorizing a certain notice in a certain forfeiture proceeding to be
4 posted for a certain amount of time on a certain website as an alternative to
5 publishing the notice in a certain newspaper; and generally relating to forfeiture
6 proceedings.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Criminal Procedure**

15 12–306.

16 (a) A notice shall be signed by the clerk and shall:

17 (1) include the caption of the case;

18 (2) describe the substance of the complaint and the relief sought;

19 (3) state the latest date on which a response may be filed;

20 (4) state that the property shall be forfeited if a response is not filed on
21 time;

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (5) state that the owner of the property may have possession of the
2 property pending forfeiture by posting a bond as provided in § 12–208 of this title; and

3 (6) tell where to file a response and whom to contact for more information
4 concerning the forfeiture.

5 (b) Within 20 days after the filing of the complaint, the notice shall be:

6 (1) posted by the sheriff on the door of the courthouse where the action is
7 pending or on a bulletin board within the immediate vicinity of the door;

8 (2) posted by the sheriff in a conspicuous place on the land, if forfeiture of
9 real property is sought; and

10 (3) **UNLESS THE PROPERTY IS A BOAT OR MOTOR VEHICLE:**

11 (I) published at least once a week in each of 3 successive weeks in a
12 newspaper of general circulation published in the county in which the action is pending[,
13 unless the property is a boat or motor vehicle]; **OR**

14 (II) **POSTED FOR A PERIOD OF 30 CONSECUTIVE DAYS ON AN**
15 **OFFICIAL WEBSITE OF THE COUNTY IN WHICH THE ACTION IS PENDING.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2018.
