AMENDMENTS TO SENATE BILL 165

AMENDMENT NO. 1

On page 1, in line 6, after “systems” insert “and certain schools”; in line 7, after “system” insert “or school”; in line 11, after “Act;” insert “authorizing certain documents and information to be provided to certain persons under certain circumstances;”; in line 20, strike the second “a”; and in line 21, strike “term” and substitute “terms”.

AMENDMENT NO. 2

On page 2, in line 4, after “(A)” insert “(1)”; in the same line, strike the comma and substitute “THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.”

(2);

in the same line, strike “PROGRAM” and substitute “PROGRAM”; and after line 5, insert:

“(3) “SCHOOL” INCLUDES A PUBLIC SCHOOL AND A NONPUBLIC SCHOOL.”

AMENDMENT NO. 3

On page 2, in lines 11 and 15, in each instance, after “SYSTEMS” insert “OR SCHOOLS”; in line 16, after “SYSTEM” insert “OR SCHOOL”; in line 19, strike “INDIVIDUAL”; and in line 24, after “SYSTEMS” insert “AND SCHOOLS”.

On page 2, in line 30, strike “A” and substitute “THIS SUBSECTION APPLIES TO A DOCUMENT SENT TO, OR INFORMATION REPORTED UNDER, THE PROGRAM THAT IS IN POSSESSION OF:”

(I) THE CENTER, A LOCAL SCHOOL SYSTEM, OR A SCHOOL UNDER THE PROGRAM;

(II) A PERSON DESCRIBED UNDER PARAGRAPH (3) OF THIS SUBSECTION; OR

(III) A PERSON AUTHORIZED TO POSSESS THE DOCUMENT OR INFORMATION UNDER REGULATIONS ADOPTED BY THE SUBCABINET.

(2) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, A”.

On page 3, in line 1, strike “OR” and substitute a comma; in the same line, after “SYSTEM” insert “, OR A SCHOOL”; after line 5, insert:

“(3) IF THERE ARE REASONABLE GROUNDS TO BELIEVE THAT AN INDIVIDUAL IS A DANGER TO THE INDIVIDUAL, ANOTHER INDIVIDUAL, OR PUBLIC SAFETY, THE CENTER, A LOCAL SCHOOL SYSTEM, OR A SCHOOL MAY PROVIDE A DOCUMENT SENT TO, OR INFORMATION REPORTED UNDER, THE PROGRAM TO THE FOLLOWING PERSONS IN THE PERFORMANCE OF THE PERSON’S DUTIES:

(I) A FEDERAL, STATE, OR LOCAL LAW ENFORCEMENT AGENCY;

(II) THE MARYLAND EMERGENCY MANAGEMENT AGENCY OR LOCAL ORGANIZATIONS FOR EMERGENCY MANAGEMENT; AND

(III) A HEALTH CARE PROFESSIONAL FOR PURPOSES OF PROVIDING TREATMENT TO THE INDIVIDUAL.;

and in lines 6 and 22, strike “**(2)**” and “**(3)**”, respectively, and substitute “**(4)**” and “**(5)**”, respectively.

AMENDMENT NO. 5

On page 3, in line 26, after “PERSON” insert “**WHO ACTS WITH REASONABLE CARE AND IN ACCORDANCE WITH ALL APPLICABLE REGULATIONS, PROCEDURES, AND PROGRAM GUIDANCE**”.

On page 4, in line 6, strike “OR” and substitute a comma; and in line 7, after “SYSTEM” insert “**, OR SCHOOL**”.
