Preamble

~~WHEREAS, During the 2016-2017 school year, Maryland public schools identified 2,337 unaccompanied homeless students who lacked stable housing, were not in the physical custody of a parent or guardian, and were not under the care or custody of a child-serving public agency; and~~

~~WHEREAS, Unaccompanied homeless minors are a largely invisible and highly vulnerable population that often lacks access to safe shelter options and supportive services designed for youth; and~~

~~WHEREAS, Without access to safe shelter options and supportive services designed for youth, unaccompanied homeless minors are at risk for trafficking and other abuse,~~

~~dropping out of school, juvenile justice involvement, poor mental and physical health outcomes, and other harms; and~~

~~WHEREAS, There is a general lack of knowledge about the unique needs of unaccompanied homeless minors and the public and private sector programs and resources that are available to meet those needs, and there is an urgent need to address gaps in those programs and resources; now, therefore,~~

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

(a) *In this section, "unaccompanied homeless minor" means a minor:*

(1) who is not in the physical custody of a parent or guardian and lacks a fixed, regular, and adequate nighttime residence; or

(2) whose status or circumstances indicate a significant danger of experiencing homelessness in the near future.

(b) There is a Workgroup to Study Shelter and Supportive Services for Unaccompanied Homeless Minors.

(c) The Workgroup consists of the following members:

(1) the Senate Chair of the Joint Committee on Ending Homelessness;

(2) the House Chair of the Joint Committee on Ending Homelessness;

(3) the Secretary of Housing and Community Development, or the Secretary's designee;

(4) the Secretary of Human Services, or the Secretary's designee;

(5) the Secretary of Juvenile Services, or the Secretary's designee;

1 (6) the Secretary of Health, or the Secretary's designee;

2 (7) the State Superintendent of Schools, or the State Superintendent's
3 designee; and

4 (8) additional members invited by the Senate Chair and House Chair of the
5 Joint Committee on Ending Homelessness.

6 (d) The Senate Chair and House Chair of the Joint Committee on Ending
7 Homelessness shall serve as cochairs of the Workgroup.

8 (e) The Joint Committee on Ending Homelessness shall provide staff for the
9 Workgroup.

10 (f) A member of the Workgroup:

11 (1) may not receive compensation as a member of the Workgroup; but

12 (2) is entitled to reimbursement for expenses under the Standard State
13 Travel Regulations, as provided in the State budget.

14 (g) The Workgroup shall:

15 (1) compile existing information on, identify, and study the unique needs of
16 unaccompanied homeless minors, and identify the public and private sector programs and
17 resources available to meet those needs;

18 (2) identify gaps in public and private sector programs and resources
19 available to meet the needs of unaccompanied homeless minors;

20 (3) identify barriers to access to safe shelter for unaccompanied homeless
21 minors, and compile information on and study shelter practices in other states; and

22 (4) make recommendations on:

23 (i) legislation, regulations, and policy initiatives to address the needs
24 of unaccompanied homeless minors in the State;

25 (ii) funding requirements and budgetary priorities to address the
26 needs of unaccompanied homeless minors in the State; and

27 (iii) any other relevant issues or considerations identified by the
28 Workgroup.

29 (h) On or before December 1, 2019, the Workgroup shall report its findings and
30 recommendations to the Governor and, in accordance with § 2-1246 of the State Government
31 Article, the General Assembly.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 ~~October~~ July 1, 2019. It shall remain effective for a period of 1 year and, at the end of June
3 30, 2020, this Act, with no further action required by the General Assembly, shall be
4 abrogated and of no further force and effect.
