## A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – School Construction Master Plan Workgroup**

3 FOR the purpose of establishing the Anne Arundel County School Construction Master  
4 Plan Workgroup; providing for the composition, chair, and staffing of the Workgroup;  
5 prohibiting a member of the Workgroup from receiving certain compensation, but  
6 authorizing the reimbursement of certain expenses; requiring the Workgroup to  
7 make recommendations regarding certain matters; requiring the Workgroup to  
8 report its findings to the Anne Arundel County Executive, the Anne Arundel County  
9 Council, the Anne Arundel County Board of Education, the Interagency Commission  
10 on School Construction, and the Anne Arundel County Delegation to the Maryland  
11 General Assembly on or before a certain date; providing for the termination of this  
12 Act; and generally relating to the Anne Arundel County School Construction Master  
13 Plan Workgroup.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That:

16 (a) There is an Anne Arundel County School Construction Master Plan  
17 Workgroup.

18 (b) The Workgroup consists of the following members:

19 (1) two Senators appointed by the President of the Senate, based on the  
20 recommendation of the chair of the Anne Arundel County Senate Delegation;

21 (2) two Delegates appointed by the Speaker of the House, based on the  
22 recommendation of the chair of the Anne Arundel County House Delegation;

23 (3) the County Executive of Anne Arundel County, or the County  
24 Executive's designee;

1           (4) two members of the Anne Arundel County Council, appointed by the  
2 chair of the County Council; and

3           (5) two members of the Anne Arundel County Board of Education,  
4 appointed by the chair of the County Board of Education.

5           (c) The members of the Workgroup shall elect the chair of the Workgroup.

6           (d) The Department of Legislative Services shall provide staff for the Workgroup.

7           (e) A member of the Workgroup:

8               (1) may not receive compensation as a member of the Workgroup; but

9               (2) is entitled to reimbursement for expenses under the Standard State  
10 Travel Regulations, as provided in the State budget.

11           (f) Based on its review of the most recent Educational Facilities Master Plan, the  
12 Workgroup shall make recommendations regarding:

13               (1) options to meet identified needs at lower costs;

14               (2) methods to improve the maintenance and rehabilitation of public  
15 schools in Anne Arundel County; and

16               (3) options to increase cost sharing.

17           (g) On or before December 31, 2019, the Workgroup shall report its findings and  
18 recommendations to the Anne Arundel County Executive, the Anne Arundel County  
19 Council, the Anne Arundel County Board of Education, the Interagency Commission on  
20 School Construction, and, in accordance with § 2–1246 of the State Government Article, the  
21 Anne Arundel County Delegation to the Maryland General Assembly.

22           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
23 1, 2019. It shall remain in effect for a period of 1 year and 1 month and, at the end of June  
24 30, 2020, this Act, with no further action required by the General Assembly, shall be  
25 abrogated and of no further force and effect.
