A BILL ENTITLED

1 AN ACT concerning

2 **Washington County – Disposition of Marriage Ceremony Fee**

3 FOR the purpose of requiring the clerk of the circuit court for Washington County to pay
4 a certain portion of a certain fee for performing a marriage ceremony to the
5 Washington County Historical Society, Incorporated; requiring the Washington
6 County Historical Society, Incorporated, to report annually on the use of certain
7 funds; authorizing certain entities to request an audit of certain records of the
8 Washington County Historical Society, Incorporated; and generally relating to the
9 distribution of the fee for performing a marriage ceremony in Washington County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

Article – Family Law

22 2–410.

24 (a) (1) Except as provided in this subsection, a judge, clerk, or deputy clerk
25 may not receive any fee, remuneration, or gift for performing a marriage ceremony.

1 (2) (i) 1. A Maryland judge's fee for performing a marriage
2 ceremony is a nonrefundable fee, payable to the clerk before a marriage license is issued,
3 in the amount of \$30 in Cecil County and \$25 in any other county.

4 2. The clerk's or deputy clerk's fee for performing a marriage
5 ceremony is \$30 in Cecil County and \$25 in any other county.

6 (ii) Except as provided in paragraph (10) of this subsection, each
7 month the clerk shall pay \$10 of each fee collected under this section into the general fund
8 of the county.

9 (iii) Except as otherwise provided in this subsection, the clerk shall
10 retain the remainder of each fee and deposit and disburse it in the same manner as other
11 fees collected by the clerk.

12 **(11) (I) IN WASHINGTON COUNTY, FROM THE REMAINING \$15, THE**
13 **CLERK SHALL PAY \$10 OF EACH FEE TO THE WASHINGTON COUNTY HISTORICAL**
14 **SOCIETY, INCORPORATED.**

15 **(II) THE WASHINGTON COUNTY HISTORICAL SOCIETY,**
16 **INCORPORATED, SHALL REPORT ANNUALLY TO THE BOARD OF COUNTY**
17 **COMMISSIONERS OF WASHINGTON COUNTY AND THE MARYLAND HISTORICAL**
18 **TRUST ON THE USE OF ALL FUNDS RECEIVED UNDER THIS SECTION.**

19 **(III) THE BOARD OF COUNTY COMMISSIONERS OF WASHINGTON**
20 **COUNTY OR THE MARYLAND HISTORICAL TRUST MAY REQUEST AT ANY TIME AN**
21 **AUDIT OF THE FINANCIAL RECORDS OF THE WASHINGTON COUNTY HISTORICAL**
22 **SOCIETY, INCORPORATED.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2019.
