## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Maryland Medical Assistance Program – Coverage of Dental Services – Repeal**  
3 **of Contingency**

4 FOR the purpose of repealing the provision of law that made the effectiveness of a certain  
5 provision of law authorizing the Maryland Medical Assistance Program to provide  
6 dental services to certain adults contingent on the Maryland Dental Action Coalition  
7 making a certain determination; making a conforming change; and generally  
8 relating to coverage of dental services under the Maryland Medical Assistance  
9 Program.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

1 That the Laws of Maryland read as follows:

2 **Article – Health – General**

3 15–103.

4 (a) (1) The Secretary shall administer the Maryland Medical Assistance  
5 Program.

6 (2) The Program:

7 (xiii) Beginning on January 1, 2019, may provide, subject to the  
8 limitations of the State budget, and as permitted by federal law, dental services for adults  
9 whose annual household income is at or below 133 percent of the poverty level.

10 **Chapter 721 of the Acts of 2017**

11 **[SECTION 3. AND BE IT FURTHER ENACTED, That:**

12 (a) Section 2 of this Act is contingent on the Maryland Dental Action Coalition  
13 determining, as part of the findings of the study authorized under Section 1(a) of this Act,  
14 that it is advisable to expand the benefits provided under the Maryland Medical Assistance  
15 Program to include dental services for adults whose annual household income is at or below  
16 133 percent of the poverty level.

17 (b) If the report authorized under Section 1(c)(1) of this Act does not include the  
18 finding described in subsection (a) of this section, Section 2 of this Act shall be null and void  
19 without the necessity of further action by the General Assembly.]

20 SECTION 4. AND BE IT FURTHER ENACTED, That[, subject to Section 3 of this  
21 Act,] this Act shall take effect June 1, 2017.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
23 1, 2019.
