CHAPTER _____

1 AN ACT concerning

2 **Cecil County – Special Taxing Districts – ~~Broadband~~ Internet Service**

3 FOR the purpose of authorizing Cecil County, for the purpose of providing ~~broadband~~
4 Internet service, to exercise certain authority in the entirety of the unincorporated
5 area of the county, establish a special taxing district if property owners in the
6 proposed district petition the county in a certain manner, impose ad valorem or
7 special taxes, and issue bonds in accordance with certain provisions of law; and
8 generally relating to authorizing special taxing districts in Cecil County for the
9 purpose of providing ~~broadband~~ Internet service.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

2 21–503.

3 (c) (1) Notwithstanding any other provision of law, a county may establish a
4 special taxing district, issue bonds, or impose an ad valorem or special tax under this
5 subtitle only if a request to the county is made by both:

6 (i) the owners of at least two-thirds of the assessed valuation of the
7 real property located in the special taxing district; and

8 (ii) at least two-thirds of the owners of the real property located in
9 the special taxing district.

10 (2) For purposes of paragraph (1)(ii) of this subsection:

11 (i) multiple owners of a single parcel are treated as a single owner;
12 and

13 (ii) a single owner of multiple parcels is treated as one owner.

15 (a) **EXCEPT AS PROVIDED IN SUBSECTION (E) OF THIS SECTION**, Cecil County
16 may exercise the authority granted under this subtitle only in a designated growth area as
17 defined in the county comprehensive plan.

18 (b) (1) The governing body of Cecil County shall hold at least one public
19 hearing on a bill establishing a special taxing district.

20 (2) At the public hearing, the governing body may consider the following
21 elements of a proposed development that would receive the proceeds of a bond:

22 (i) development design standards;

23 (ii) the use of transfer of development rights or other methods of
24 increasing the density of development;

25 (iii) design and use of open space; and

26 (iv) availability and design of recreational and educational facilities.

27 (c) A law enacted by Cecil County under this subtitle shall require that adequate
28 debt service reserve funds be maintained.

29 (d) **[Notwithstanding] EXCEPT AS PROVIDED IN SUBSECTION (E)(2) OF THIS**
30 **SECTION AND NOTWITHSTANDING § 21–503(c)** of this subtitle, before Cecil County may

1 establish a special taxing district, all of the owners of real property in the proposed special
2 taxing district shall petition the county to establish the special taxing district.

3 **(E) FOR THE PURPOSE OF PROVIDING ~~BROADBAND~~ INTERNET SERVICE,**
4 **CECIL COUNTY MAY:**

5 **(1) EXERCISE THE AUTHORITY GRANTED UNDER THIS SUBTITLE IN**
6 **THE ENTIRETY OF THE UNINCORPORATED AREA OF THE COUNTY;**

7 **(2) ESTABLISH A SPECIAL TAXING DISTRICT IF PROPERTY OWNERS IN**
8 **THE PROPOSED SPECIAL TAXING DISTRICT PETITION THE COUNTY IN ACCORDANCE**
9 **WITH § 21-503(C) OF THIS SUBTITLE; AND**

10 **(3) IMPOSE AD VALOREM OR SPECIAL TAXES AND ISSUE BONDS**
11 **UNDER THIS SUBTITLE.**

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
13 1, 2019.
